I) As the Bidders are exempted from depositing Bid security/ EMD as per Lr. 8943 Dt.18.03.2021, they have to submit **“Bid Security Declaration”** in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents.
- II) The Bidders shall transfer **online the cost of Bid Documents as mentioned in Col.4** of table above towards the cost of bid through a process as mentioned under DTCN
- III) As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule of rates.
- IV) The Authority will not be held responsible for any technical snag or network failure during on-line bidding.
