No. _____ /TC, In partial modification of Resolution No.-69941 dtd.30.08.2013 & subsequent Corrigendum No. 7616/TC dated 25.09.2013 of Odisha State Tele Awards Rules-2013, the State Government in Culture Department have been pleased to amend the following provisions in the State Tele Awards-2013, which are as follows:

i) that, the provision of last date for receipt of entry at para-5 of the Odisha State Tele Awards Rules-2013 may be read as "Last date of receipt of application of awards envisaged under Rules along with the print / prints in the Directorate of Culture, Govt. of Odisha shall be 30.09.2013 (instead of last working day in the month of August of the year following the year to which the awards relates to)"

ii) This corrigendum is only applicable for receiving of print / prints for the Odisha State Tele Awards 2012 and for the subsequent years the provision of last date for receipt of entry at para-5 of the Odisha State Tele Awards Rules-2013 may be "Last date of receipt of application of awards envisaged under Rules along with the print / prints in the Directorate of Culture, Govt. of Odisha shall be the last working day in the month of August of the year following the year to which the awards relates to".

iii) In the award list furnished at Schedule-II, two new awards have been inserted which is as follows:

- Award for Best Story Writer with award value of Rs.15,000/- & a Certificate of Honour;
- Award for Special Jury Awards with award value of Rs.15,000/- & a Certificate of Honour;

iv) In the award list furnished at Schedule-II, two new awards have been created out of the existing award i.e r Best Tele Film by way of bifurcating the existing award value which is as follows:

- Award for the Producer with award value of Rs.15,000/- & a Certificate of Honour;
- Award for the Director with award value of Rs.10,000/- & a Certificate of Honour;

3. Other terms & condition of Odisha State Tele Awards Rules-2013 shall remain unchanged.
