1st Corrigendum to E-procurement Notice No.EEMIDN 01 of 2021-22.

The E-procurement Notice No.EEMIDN-01 of 2021-22 invited by the Executive Engineer, M.I.Division, Nayagarh is hereby modified as follows

1. Regarding Bid Security (EMD) : As per Finance Department Govt. of Odisha No 8943 Dated- 18.03.2021, due to Covid-19 pandemic, no provision regarding Bid Security should be kept in the Bid Documents and only provision for “ Bid Security Declaration” should be kept. Further, wherever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender. The bidders should execute a Bid Security Declaration in lieu of Bid security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents.
2. Class of Contractor : Read as ‘B & A’ Class contractor of sl.no-07 instead of ‘C & B’ Class.

All other terms and condition in DTCN remains unchanged.
