- (i) The construction work of statues shall be completed by 3 months from the date of issue of work order with photographs.
- (ii) The Firm/Agency shall collect the photograph/sketch of the statue within 7 days of the receipt of work order and begin the work in the following manner:

(a) Clay model

: by 1 month of the work order (including spot visit of experts/Department

Officials/Others)

(b) Plaster of Paris model

by next 1 month

(c) Piece-moulding/Wax model & final Casting with lost of wax process, Anchor Rod Welding, Base Inner Angel Frame Welding

by next 1 month (including technical Inspection of expert members)

(iii) The completion of statue should be reported to Director, Odia Language, Literature & Culture for installation at the site selected by Site Selection Committee : by 10 days of the expiry of work order.

(iv) Payment to the firm shall be released soon after delivery/installation of the statue as follows

80% - After supply of the statue for installation.

10% - After installation of the statue

10% - 01

One month after the installation or after clearance of taxes, levies, penalties, royalties etc. for Authorities concerned.

(v) Penalties for non-completion of statue by due date

Penalties shall be imposed and 5% to 10% shall be deducted from the bill as

per Govt. order.

(vi) Advance System

No advance shall be paid for the work

(vii) Refund of EMD

: The EMD enclosed with Technical Bid shall be refunded to the other firms / agencies except selected Bidders after issue of work order. Similarly, the EMD of selected firms shall be refunded to them only after successfully completion
