Terms & Conditions

The firm/agency/sculptor shall have to abide by the following terms and conditions while executing the work orders.

- (i) They have to furnish a bank guarantee/@ 10% of the estimated cost of the work, which may be refundable after the work is completed.
- (ii) The construction work of statues shall be completed by 3 months from the date of issue of work order.
- (iii) The firm/agency shall collect the photograph/sketch of the statue within 7 days of the receipt of work order and begin the work in the following stages-

Clay model - by 1 month of the work order (including spot visit of experts /Deptt. Officials).

Plaster of Paris Model - by next 1 month

Piece- moulding/ Wax model & Final Casting - by next 1 month (including technical inspection of expert members)

- (iii) The completion of statue should be reported
To Director, Culture for installation at the
Site selected by Site Selection Committee - by 10 days of the expiry of
work order.
- (iv) Payment to the firm shall be released soon after delivery/installation of the statue as follows:
 - 70% - After supply of the statue for installation.
 - 20% - After installation of the statue
 - 10% - one month after the installation or after clearance of
taxes, levies, penalties, royalties etc. for Authorities
concerned.
- (v) Penalties for non-completion of statue by due date-Penalties shall be imposed and 5% to 10% shall be deducted from the bill as per Govt. order.
- (vi) No advance shall be paid for the work.
- (vii) Refundable EMD-@ 1% of the estimated cost shall have to be enclosed with the tender papers (Technical Bid). The EMD should be drawn in favour of Director, Culture.
- (viii) Incomplete/applications shall not be taken for consideration.
- (ix) Director, Culture reserves the right to cancel/ modify or change the tender without assigning any reason thereof.
