Executive Engineer Rural Works Division, Kendrapara on behalf of Governor of Odisha invites Percentage rate bids through e-procurement for following **Building** works for the year 2021-22 as per Annexure. The bid should be submitted through on-line in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha of equivalent class Registered with Central Government/ State Government / Railway / C.P.W.D / M.E.S. The bidders must posses compatible Digital Signature Certificate (DSC) of Class-II & Class-III as per Annexure. The registered Bidders of outside Odisha, can also participate in this process after necessary portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Govt. before award of the work.

1. Class of Contractor.

: As per Column-6 of Annexure.

2. Time for Completion

: As per Column-7 of Annexure.

3. E.M.D required

: No EMD is required as per Office Memorandum No.8493 dt.18.03.2021 of Finance Department, Govt of Odisha. But <u>Bid Security declaration</u> should be furnished by the bidders as mentioned in the DTCN. The

amount as specified in the column 4 of Annexure.

4. Cost of tender paper

: Cost of tender paper is to be remitted ONLINE as specified in column-5

of the Annexure.

5. Mode of submission tender

:Tender should be submitted online in www.tendersorissa.gov.in

6. Decision to conduct Lottery

: If required, to decide the agency, transparent Lottery shall be conducted on dt.02.09.2021 at 11.00 A.M in Office Chamber of the under signed.

- 8. Bid documents consisting of qualification information and eligibility criteria of bidders, plans, specifications, drawings & the schedule of quantities of the various classes of work is available in website <a href="www.tendersorissa.gov.in">www.tendersorissa.gov.in</a>
- 9. The bid uploaded for the work which are valid shall remain open for acceptance in the Website for a period of ninety days from the last date of receipt of bids. If any Bidder / Tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall be forfeited.
- 10. Tenderers represented through power of attorney holder should ensure that the power of attorney is duly signed and identified through an affidavit from first class Magistrate containing the photograph of both the license holder and the person to whom the power of attorney is given or else the tender will be considered for rejection.
- 11. If the office happens to be closed due to subsequent declaration as holidays by Government of local authority on the date of opening as specified above, tenders will be opened on the immediate next working day at the same specified time and venue.

- 12. If the rate quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected and tender shall be finalized basing on merits of rest bids. The bidders are requested to quote their rate up to two decimal points, for finalization of tenders details can be seen in DTCN.
- 13. The successful tenderer should produce all the original documents at the time opening of tender for verification.
- 14. Additional performance security, in pursuance of amendment to para-3.5.5 (v) of OPWD Code, Volume-I Vide Works Department Office Memorandum no.4559 dt.05.04.2021, shall be obtained from the bidder when the bid amount is less than below 5% there shall be no deposit of Additional Performance Security, and the bidders quoting their rates the range of difference between the estimated cost put to tender and bid amount from 5% and above and below 10% / from 10% and above shall be liable to deposit an Additional Performance Security to the extent of 50% of (Difference between estimated cost put to tender and bid amount) / 150% of (Difference between estimated cost put to tender and bid amount) respectively. Additional Performance Security (A.P.S) in shape of Term deposit Receipt pledged in favour of the Executive Engineer, Rural Works Division, Kendrapara/ Bank Guarantee in favour of the Executive Engineer, Rural Works Division, Kendrapara from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance(LoA) by the Divisional Officer (by e-mail) to the successful bidder, otherwise the bid of the successful Bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder. More ever, this arrangement is made keeping in view the acute financial crunch on account of slowdown in economic due to pandemic COVID-19. Further proceeding for Blacklisting shall be initiated against the bidder as per amendment to Para 3.5.5 (V) of OPWD Code, Volume-I vide Works Department Office Memorandum no.14459/W dated 20.09.2018.

## 15. Exemption of EMD

To avail the exemption of EMD, the intending Engineering Contractor should get the no. & name of work recorded in the original registration certificate. He should produce an affidavit along with the tender paper to the effect that he has not availed the exemption of EMD for 3 (Three) works during current financial year along with photocopy of license. Similarly the S.C Contractor desires to avail price preference and EMD exemption shall have to produce the required affidavit claiming the same.

16. Security for the due fulfillment of a contract should be taken. The Security may be taken in shape of N.S.C/Post Office Time Deposit Account/ Kissan Vikas Patra/ Bank Guarantee in favour of the Divisional Officer from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar towards EMD/initial Security Deposit / any other Security Deposit from the contractor.

## 17. Black listing of the contractor / bidder

If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case, the L2 bidder if fulfils, other required criteria would be called for drawing agreement for execution of work subject to the condition that L2 Bidder negotiates at par with the rate quoted by the L1 bidder otherwise the tender will be cancelled.

- 18. The rates to be quoted by the contractor shall be excluding GST. The implementation of GST rules by the Government of Odisha is to be accepted by the bigger at any point of time.
- 3. If a single tender is received in response to this notice, then tender for such work will be cancelled at first instance.

- 3. Subsequent Modification/ Corrigendum/ Addendum if required shall be appeared in the website only.
