14. No EMD (Bid security) is required as per order No. 893 ,dtd. 18.03.21 of Finance dept. But "Bid Security declaration" should be furnished by the bidders as per the format mentioned in the DTCN failing which the bid shall be rejected.

15. Engineer contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed EMD Exemption for **more than two nos.** of works during this financial year 2021-22 and to show the original registration certificate to the tender opening authority for verification after the opening of tender without which the tender will be rejected.

16. The successful bidder who has quoted less bid price/rate than the estimated cost put to tender shall have to furnish **Additional Performance Security (APS)** as per Works Department O.M No 4559 , dated 05.04.2021 in shape of fixed deposit receipt/Term Deposit Receipt duly pledged in favour of Executive Engineer ,M.I Division, Malkangiri as per the amount mentioned in the table below from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar **within seven days** of issue of Letter of Acceptance (LoA) by the Divisional Officer (By e-mail/post), otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder

18. The bidder quoting more than 14.99% less (decimals up to two numbers will be taken for all practical purpose) rate such bid will be rejected. GST to be imposed as applicable

19. Further corrigendum if any can be seen from the website: www.tendersodisha.gov.in / office Notice Board. If the office happens to be closed on the stipulated date of opening of bids as specified, the bids will be opened on the next working day.

20. The bid is liable to be rejected if the TDRs submitted found fake and criminal action shall be initiated against the bidder.
