NOTICE INVITING TENDER (NIT)

NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **Superintending Engineer, P.H. Division, Keonjhar**, Tender Inviting Authority (TIA) on behalf of Governor of Odisha invites sealed tenders in single bid systems from manufacturers/dealer/sub-dealers in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) from eligible bidders meeting the minimum Eligible Criteria for supply of materials as detailed herein, which is to be delivered at P.H. stores at **Joda**. The bid should be submitted on-line in the website **www.tendersorissa.gov.in** by eligible manufacturer. The bidders should have the necessary Portal Enrolment with his own Digital Signature Certificate.

2. Mode of Submission of tender: Tender must be submitted online only in **www.tendersorissa.gov.in**
3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
4. The bidder should make payment through online towards Tender Paper Cost. No off line receipt of Tender Paper Cost will be allowed in e-Procurement portal of Government of Odisha.
5. The scanned copy of Registration Certificate/Dealership/Sub Dealership authorization, GST, PAN, Affidavits including required papers up loaded through website should be produced in original to the **Superintending Engineer, P.H. Division, Keonjhar** for verification by **17:00Hrs of dt.09.08.2021** so as to enable opening of Technical Bid i.e., at **11:00 Hrs of dt.10.08.2021**.

7. **Minimum Eligibility Criteria:**

The Bidder shall be manufacturer/ dealer/sub-dealer of the materials, having valid GST and PAN.

8. The manufacturers should not be black listed/debarred/disqualified with respect to the quality issues by any Govt./Govt. undertaking as a procuring entity, for supply of pump motor sets in India, in the last three years from the date of submission of the tender (Self-declaration certificate shall be submitted by the manufacturers in the form of affidavit).

9. The bidders who have in last 3 financial years applied for/ are undergoing corporate debt. Restructuring (CDR) / Strategic Debt Restructuring (SDR) or facing recovery proceedings from Financial Institutions or those are facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR) are not eligible for qualification. Self-declaration certificate by the bidder in the form of affidavit is to be submitted.

10. The bidder/manufacturers should have valid BIS license for making ISI mark on their product for at least 5(five) years by last date of bidding.

11. The manufacturer shall not have un satisfactory performance in Indian project for at least three years.

12. Document required:

- ❖ Copy of the valid BIS License of the product to be supplied.
- ❖ Document/Certificate in support of satisfactory performance of pump motors in Indian projects for at least three years shall be furnished duly certified by an officer not below the rank of Executive Engineer or appropriate authority.

13. **Financial Criteria:**

Bidders should have annual financial turnover of not less than 40% of estimated cost in at least one year during last 5 (Five) preceding financial years. Inflation/Escalation @10% per financial year (on compound basis) shall be considered on the value of annual turnover of the proceeding years.

Bidder shall furnish audited annual financial year statements i.e. balance sheets, profit and loss accounts, corresponding schedules and auditors support as a part of published annual report in support of meeting the financial criteria as mentioned above.

Escalation Factor (On Compound Basis):

Following enhancement/Compounding factors will be used for the costs of works executed and the financial figures to a common base value.

14. The bid for the work shall remain open for acceptance for a period of 90 **(Ninety Days)** from the date of opening of price bids. If any Bidder/Tenderer withdraws his bids/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
15. Bid security declaration shall be submitted in lieu of EMD in Schedule-A, non-submission of Bid Security Declaration will call for rejection of bid.

17. Subsequent Corrigendum if required shall be appeared in the website.
18. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
