





The Sealed Quotation will be received from **10.00 hours dtd. 28.07.2021 to 17.00 hours of 05.08.2021** and to be opened at **11.30 hours of 06.08.2021** in the Office of Executive Engineer, Phulbani (R & B) Division, Phulbani in the Tender Box having Quotation call notice no-E.E. -R&B-PLB-04/2021-22 noted on the cover. If the Office happens to be closed on the date of receipt/ opening of the Quotation as specified, the quotations will be received/ opened in presence of the Quotationer or their authorized agent on the next working day at the same time and venue.

The cost of quotation document which is non-refundable is to be submitted in shape of Demand draft for Rs. 6000/- issued from any Scheduled Bank payable at Phulbani drawn in favour of Executive Engineer, Phulbani (R & B) Division on or before the last date of receipt of Quotation and should be enclosed in the Quotation document.
