

1. The word '**optional**' appearing in the proviso under educational qualifications prescribed for the post of TGT Arts shall be substituted and read as "**optional/compulsory**'.
2. The words '**Bachelor in Education (B. Ed)**' appearing at the educational qualifications prescribed for the post of TGT Arts, TGT Science (PCM) & TGT Science (CBZ) shall be substituted and read as '**Bachelor in Education (B. ED) / 3- year integrated B.Ed.-M.Ed Course from a NCTE recognised Institution**'.






