The Director of Horticulture invites Expression of Interest in sealed covers from Cold Store Owners (for Seed Potato), Public sector undertakings / Govt. Institutes / SAUs / Nationally Recognised Seed Producers/ Registered Seed suppliers for supply of Seed Potato / Onion Seed / Garlic Bulb during Rabi 2021-22 for empanelment of suppliers for sale of Seed Potato / Onion Seed / Garlic Bulb to the farmers of Odisha. The sealed Expression of Interest should be submitted individually (crop wise) to this Directorate on or before 13.09.2021 by 5.30 P.M. through Registered Post / Speed Post (Indian Post) / Courier Service only. The same will be opened on 14.09.2021 at 11.00 A.M. in the Board Room at Ground floor of Krushi Bhawan, Bhubaneswar. The sealed envelopes should be superscripted with “Empanelment of Suppliers of seed potatoes / Onion Seed / Garlic Bulb individually (crop wise) during Rabi – 2021-22”. TERMS OF REFERENCE FOR SUPPLY OF SEED POTATO, ONION SEED AND GARLIC BULB DURING RABI 2021-22

A. EoI FOR SUPPLY OF SEED POTATO

2. The EoI is meant for empanelment of supply of certified/G3/G4 seed Potato during Rabi 2021-22 by Cold Store Owners (Running cold stores having a tie up with registered seed potato producers), Public sector undertakings / Govt. Institutes/SAUs/Nationally recognised seed potato producers/ Registered Seed suppliers.
3. The interested agencies may download the EoI documents including format of Technical bid & Financial bid and details of different activities etc. to be undertaken from the department website **www.odihort.nic.in** and also from **www.odisha.gov.in**
4. The last date for submission of the Expression of Interest (EoI) is 13.09.2021 at 5.30 PM. The Technical bid will be opened on 14.09.2021 at 11.00 AM in the Board Room at the Ground Floor of Krushi Bhawan and the Financial Bid will be opened on 14.09.2021 at 03.30 PM in the same venue.
5. One agency is entitled to submit one Bid only.
6. The requirement of seed potatoes for the farmers of the Odisha will be around 7500 MT under Govt. Programme during Rabi 2021-22.
7. The seed potatoes will be sold to the farmers during Rabi 2021-22. The sale of Seed Potato is the sole responsibility of the supplier by arranging all the requisites for selling to the farmers.
8. The offered price in the Financial Bid should include all expenses upto Block point.
9. The bidders or their authorized representatives shall be present at the time of opening of the EoI. In case of absence of the bidders or their representatives the committee has the right to open the EoI.
10. Quality & purity of seed potato is the sole responsibility of the seed supplying agency (size of the tuber: 25mm to 45 mm; varietal mix should not be more than 0.1%; cut, bruised, unshapely, cracked tubers or those damaged by insects, slugs or worms shall not exceed more than 1% by weight).
11. The cost of verification including logistics and conveyance of expert team at all levels and cost of quality testing will be borne by the supplying agency.

12. The Technical Bid is required to be accompanied with :
 - a. Up to date GST clearance certificate,
 - b. PAN/TAN number
 - c. IT return / clearance certificate,
 - d. Service Tax registration / clearance certificate
 - e. Seed certification by any authentic Certification Agency.
 - f. Department of Biotechnology (DBT) certificate wherever applicable.
 - g. Source certificate for supply of seed potato.

13. Kufri Jyoti, Kufri Pukhraj, Kufri Himalini, Kufri Ganga, Kufri Sinduri, Kufri Lalima, Kufri Khyati& Kufri Chipsona-3 suitable for Rabi cultivation in Odisha is to be procured.
14. The Financial Bid should be variety wise to the Block point only.
15. Financial Bid of bidders will be opened only for those who qualify the Technical bid.
16. Any dispute arising due to seed quality in the field will be verified by scientists from OUAT / KVK / CTCRI / CHES & Dept. officials or team as will be constituted by Director of Horticulture, Odisha.
17. Empanelled seed suppliers can supply seed potato to any of the district in Odisha. One supplier can supply seed potato in more than one district. Director of Horticulture reserves the right to allot districts to the bidders in case of need or emergency.
18. The seed potatoes will be verified by the expert team constituted by the Director of Horticulture prior to seed supply at the storage points.
19. The seed potatoes will also be verified by the expert committee constituted by the concerned DDH/ADH after arrival / before delivery to the farmers.
20. The Director of Horticulture, Odisha reserves the right to reject the lowest bid quoted by any supplier / organization / agency, if not satisfied with concerned supplier / organizations / agency's credibility and past experiences.

Further the Director of Horticulture, Odisha also reserves the right to accept / reject/ modify any or all EoI without assigning any reason thereof.
21. **Bid Security declaration** with stipulation **“that if I withdraw and modify the Bid during period of validity etc., I will be suspended for a period of three years”** is to be attached with the EoI.

22. Further, successful empanelled supplier(s) will have to produce the Bank Guarantee from a Commercial Bank towards performance security with validity up to March, 2022. The Bank Guarantee amount will be 3% of the value of quantity of Seed Potato proposed to be sold to the farmers.
23. The bidder shall fill up the Financial bid as well as Technical bid and submit in separate sealed covers along with necessary documents, superscribed as **“Technical Bid” / “Financial Bid”** as the case may be. Both the bids should also be kept inside another sealed envelope and superscribed with **“EoI for empanelment of suppliers for supply of seed potatoes during Rabi2021-22”**.The same should be sent through P & T department Registered post / Speed Post/ Courier services only.
24. Intending bidder will have to submit the undertaking in a Rs. 10/- stamp paper stating the followings.
 - a. The decision of the evaluation committee will be final and binding.
 - b. Agency will be liable for seed quality and binding with Seed Act.
 - c. If the seed quality is found to be defective or poor, the agency will be penalised as per the recommendations of the technical committee constituted for this purpose and as per seed Act and Rule.
 - d. I (The seed supplier) cannot challenge the decision of the evaluation committee in respect of technical bid as well as financial bid in any forum.
25. The technical bids will be evaluated by a committee constituted for the purpose and the findings of the committee will be final and binding. The same cannot be challenged in any forum thereafter.
26. Agencies failing to supply their offered stock in time shall be liable to penalty as decided by the Govt.

B. EoI FOR SUPPLY OF ONION SEED

1. The EoI is meant for empanelment of supply of certified Onion Seed during Rabi 2021-22 by Public sector undertakings/ Govt. Institutes/ SAUs/ Nationally recognised Onion Seed Producers/ Registered Seed suppliers.
2. The interested agencies may download the EoI documents including format of Technical bid and Financial Bid from department, website **www.odihort.in** and also from **www.orissa.gov.in**
3. The last date for submission of the Expression of Interest (EoI) is 13.09.2021 at 5.30PM. The Technical bid will be opened on 14.09.2021 at 11.00AM in the Board Room at the Ground Floor of Krushi Bhawan and the Financial Bid will be opened on 14.09.2021 at 03.30 PM in the same venue.

4. One agency is entitled to submit one Bid only.
5. The requirement of Onion Seed for the farmers of the Odisha will be around 25 MT (250 Qntl.) under Govt. assisted Programme during Rabi 2021-22.
6. The Onion Seed will be sold to the farmers during Rabi 2021-22. The sale of Onion Seed is the sole responsibility of the supplier by arranging all the requisites for selling to the farmers.
7. The offered price in the Financial Bid should include all expenses upto Block point.
8. The bidder or authorized representative should be present at the time of opening of the EoI. In case of absence of the bidders or their representatives the committee has the right to open the EoI.
9. Quality of the Onion seeds is the sole responsibility of the agency. Any dispute arising due to Onion seeds quality in the field will be verified through scientist from OUAT/ KVK/ CHES/RRTTS Dept. officials or team as constituted by the Director of Horticulture, Odisha.
10. The source verification of Onion seeds variety Bhima Super, Bhima Shakti, Bhima Red, Arka Niketan, Baswanta-780, Agrifound Light Red and N-53; production capacity; technical manpower etc. shall be verified by the expert team constituted by the Director of Horticulture. The cost of verification at all levels and cost of other testing if required will be borne by the supplying agency.
11. The agency has to submit the following documents:
 - a. Seed Quality Certificate (i.e. germination percentage: minimum 70%, moisture percentage: maximum 8%),
 - b. Production capacity,
 - c. Previous experience,
 - d. Valid GST certificate,
 - e. PAN No. / TAN No.
 - f. Undertaking in a Rs. 10 stamp paper containing the followings.
 - The decision of the evaluation committee will be final and binding on me and the same cannot be challenged at any forum thereafter.
 - I (The agency) shall be liable for poor germination & improper genetic purity of Onion seeds.
 - If the Onion seeds quality is found improper, I (The agency) will refund the cost of seeds and pay compensation as decided by the technical committee constituted for this purpose.
 - I will supply Onion seeds to the farmers of the state at the offered price irrespective of the Block points.

12. The bidder shall fill up the financial bid as well as Technical bid and submit in a separate sealed cover along with necessary documents. The Technical Bid and Financial Bid should be put in separate envelopes and superscribed as "Technical Bid" / "Financial Bid" as the case may be. Both the bids should also be put inside another sealed envelope and superscribed with EoI "**For empanelment of agency to supply Onion seeds for Rabi-2021-22**". The same should be sent through P & T Department by Registered Post/ Speed Post & Courier services only to the office of the Director of Horticulture, Odisha, Bhubaneswar.
13. The Technical Bids will be evaluated by a committee constituted for the purpose and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit undertaking in this regard.
14. The Director of Horticulture reserves the right to reject the bid quoted by any organization / agency, if not satisfied with concerned organisation / agency's credibility and past experience. 2. The interested agencies may download the EoI documents including format of Technical bid and Financial Bid from department, website **www.odihort.in** and also from **www.orissa.gov.in**
3. The last date for submission of the Expression of Interest (EoI) is 13.09.2021 at 5.30 PM. The Technical bid will be opened on 14.09.2021 at 11.00 AM in the Board Room at the Ground Floor of Krushi Bhawan and the Financial Bid will be opened on 14.09.2021 at 03.30 PM in the same venue.
4. One agency is entitled to submit one Bid only.
5. The requirement of Garlic Bulb for the farmers of the Odisha will be around 400 Qntl. under Govt. assisted Programme during Rabi 2021-22.
6. **The offered price in the Financial Bid should include all expenses upto Block point.**
7. The bidder or authorized representative should be present at the time of opening of the EoI. In case of absence of the bidders or their representatives the committee has the right to open the EoI.

8. Quality of the Garlic Bulbs is the sole responsibility of the agency. Any dispute arising due to Garlic Bulbs quality in the field will be verified through scientist from OUAT/ KVK/ CHES/RRTTS Dept. officials or team as constituted by the Director of Horticulture, Odisha.
9. The source verification of Garlic Bulbs variety Yamuna Safed 3, Yamuna Safed 4, Agrifound White, Bhima Omkar, Bhima Purple etc; production capacity; technical manpower etc. shall be verified by the expert team constituted by the Director of Horticulture. The cost of verification at all levels and cost of other testing if required will be borne by the supplying agency.
10. The agency has to submit the following documents:

 - b. Production capacity,
 - c. Previous experience,
 - d. Valid GST certificate,
 - e. PAN No. / TAN No.
 - f. Undertaking in a Rs. 10 stamp paper containing the followings.

 - I (The agency) shall be liable for poor germination & improper genetic purity of Garlic Bulbs.
 - If the Garlic Bulbs quality is found improper, I (The agency) will refund the cost of Bulbs and pay compensation as decided by the technical committee constituted for this purpose.
 - I will supply Garlic Bulbs to the farmers of the state at the offered price irrespective of the Block points.
11. The bidder shall fill up the financial bid as well as Technical bid and submit in a separate sealed cover along with necessary documents. The Technical Bid and Financial Bid should be put in separate envelopes and superscribed as "Technical Bid" / "Financial Bid" as the case may be. Both the bids should also be put inside another sealed envelope and superscribed with EoI "**For empanelment of agency to supply Garlic Bulbs for Rabi-2021-22**".
