

02. The bidders must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
03. The Authority will not be held responsible for any technical snag or network failure during online bidding.
04. The Bidder may ask questions in the e-procurement portal using his/her DSC from **Date.** 10.08.2021 to Date 21.08.2021 **DURING THE OFFICE HOURS** i.e. from 10.00 A.M. to 5.00 P.M.
05. Subsequent corrigendum/addendum if required shall only be available in web site indicated above.
06. Scanned clear copies should be uploaded. **Non-visible copies of Documents may be liable for rejection.**
07. Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in
08. The Original affidavit regarding correctness of all documents for each work separately should be made and scan copy of such affidavit is to be uploaded online.
09. "Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the **APSD as per Memorandum No. 4559 Dated. 05.04.2021 of Works Department Govt. of Odisha.**
10. **Exemption of E.M.D.**
To avail the exemption of E.M.D. the intending Engineering contractor should have to furnish an affidavit to the effect that he has not been awarded works maximum up to 3 Nos. during the current financial year along with the tender paper. The successful Engineering Contractor shall have to submit the original registration license before drawl of agreement for making necessary entry in it towards EMD exemption failing which his tender will be cancelled and the registration authority will be moved for taking penal action against him.
11. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of the rest of bids. But if more than one bid is quoted at 14.99% (decimals up to two numbers will be taken for all practical purposes) less than

- the tender amount, the tender will be finalized through a transparent lottery system in the presence of the bidders/their authorized representatives.
12. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without Government permission.
 13. Tender paper cost, EMD, PAN, GSTIN & No relation certificate in shape of affidavit, clear scanned copy of original valid license, affidavit regarding authenticity of document and affidavit to avail price preference in case of SC/ST contractors, should be uploaded for each work separately along with the bid document.
 14. **Submission of fake TDRs shall lead to rejection of Bids and criminal action shall be initiated against the concerned bidders.**
 15. The cost of Bid documents and Bid security must be uploaded by bidders in *online mode*.
 16. **Only those bidders who successfully remit their cost of Tender paper would be eligible to participate in the tender/bid process. The bidders with pending of failure payment status shall not be able to submit their bid.**
 17. The successful bidder shall have to produce original registration certificate, GSTIN, PAN for verification before drawl of agreement and furnish the attested Xerox copies of such documents at that time.
 18. Penalty will be imposed as per agreement condition if the work is not completed within the stipulated period or the progress of work is not as per the work programme.
 19. If the bidders withdraws the bid after bid opening during the period of bid validity the EMD will be forfeited.
 20. The single tender received shall be cancelled without opening the bid in 1st call.
 21. Agreement will be drawn/works will be taken up as per the availability of funds.
 22. Quality control test as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/Medium/Major Irrigation Organization. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
 23. The intending bidders are required to furnish their e-mail address and cell phone number so as to inform them anything relating to the tender.
 24. Successful tenderer will be intimated for drawl of agreement.
 25. If the office happens to be closed on the last date of closing or opening of the bids as specified, holidays in Government local authority the tenders will be closed or opened on the immediate next working day at same time and venue respectively, as the case may be.
 26. G.S.T. on works will be applicable as per the guidelines of Govt. of Odisha and will be deducted from works bill accordingly.
 27. The intending bidders should offer their rates excluding GST. The GST as applicable for the work contract shall be paid over bill amount of the work at the time of payment of each bill on production of Tax Invoice. The amount put to tender is exclusive of G.S.T.
 28. In case of lottery need to be conducted in accordance with the Works Department order No. 12366 dated. 08.11.2013, the lottery will be held on 20.09.2021 at 11.00 a.m. onwards.
 29. Authority reserves the right to reject any or all the tenders without assigning any reason thereof.
 30. As per OPWD Code clause 12.4 (Appendix-IIX (A)) the contractors participated in the above tender mandated to register themselves in Contractor Data Base Management System (C.D.M.S.) available at www.cdmsodisha.gov.in.
 31. The bidders are not required to submit the Bid Security / E.M.D. as per Works Department Letter No. 5984 Dated 27.04.2021. They are requested to submit only a **"Bid Security Declaration Form"** in the prescribed format attached with D.T.C.N.
