1.1 Government of Odisha (Department of Water Resources), through Government of India, has received ODA loan from Japan International Co-operation Agency (JICA) towards the cost of execution of Rengali Irrigation Project, Phase-II of LBC-II, (Loan Agreement No. ID-P 244) and intends to utilise a part of the loan to cover eligible payments for the package of work, covered under this Bid.

Bidding will be conducted through procedures in accordance with the applicable guideline for procurement under Japanese ODA Loan and is open to all eligible bidders from all eligible source countries as defined in the Loan Agreement, provided the Bidder is not debarred from participating in such tenders.

All the interested contractors need to be registered in the State portal and must possess compatible digital signature certificate of Class – II and III for on line bidding. The Contractors not registered in the State of Odisha can also participate in this online tender process after necessary portal enrolment but shall have to be subsequently registered with appropriate authority of the Government of Odisha within a month of acceptance of bid. The bidders not registered in Odisha are required to submit an undertaking in the form of an affidavit that, they are not registered under the OGST Act in the State of Odisha as they have not started any business in the State and they have no liabilities under the said Act. The successful bidders have to produce their documents regarding GST before signing the agreement.

- The Bid is to be submitted in two separate covers, namely Technical Bid and Financial Bid. The Technical Bid (cover-1) must be accompanied with Bid Security declaration in lieu of Bid security and submit on-line. Bid security declaration as per format of bid security declaration available in section (V) form annexture J of bid document.. In case the bidder desires to hire machineries and/or equipments as asked for in the document, from outside the State, he/she is required to furnish Additional Bid Security (extra) 1% of the amount put to Bid which shall stand forfeited in case the bidder fails to mobilize the machineries within the stipulated time as per the bid document. The additional bid security is to be duly pledged in favour of the Superintending Engineer, Left Canal Division No III, Duburi for Pkg. J (I) and Superintending Engineer, Left Canal Division No IV, Bhuban for Pkg. G (I) & G (II). The scanned copy of Additional Bid Security(if applicable) document will be submitted in web site at the time of submission of bid with the bid papers.
- 1.3 The cost of bid document is INR `10,000/- (Non-refundable) only to be paid on-line.

- 1.5 The Technical Bid (cover-I) consisting of qualification, information and eligibility criteria of bidders, plans, specifications and bill of quantities of the works are available in web-site www.tendersodisha.gov.in and should be submitted in the same web-site with scanned copies of valid registration certificate, GSTIN, PAN card, Bid security, No relation certificate, Credentials establishing minimum eligibility criteria etc. and an affidavit about the authenticity of the documents submitted failing which his/her bid shall be declared as non-responsive & thus liable for rejection.
- 1.6 The Financial Bid (cover-II) consisting of the schedule of quantities of works is available in web-site -www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can also be seen in the said web-site. Interested bidders may obtain further information, if any, at the above web-site. The date and time of opening of Financial Bid (Cover II) will be intimated to the qualified bidders after evaluation of the Technical Bid (Cover I).
- 1.7 The bid must be valid for a minimum period of 120 days from the last date of opening of bid (Cover-I). If any bidder withdraws his bid before the said period or makes any modification in the terms and conditions of the bid, the bidder will be suspended for being eligible for bidding/award of all future contract(s) of Government of Odisha for a period of three years from the date of committing such breach
- 1.8 No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period two years after his retirement from Govt. Service, without Govt. permission.
- 1.9 Other details can be seen in the bidding documents, which are available in website www.tendersodisha.gov.in.
- 1.10 The original copy of CRC (Contractors Registration Certificate), GSTIN, PAN, Affidavit, Bid security declaration and other documents should be produced in original to **Chief Engineer**, **JICA Projects**, **BLB**, **Sukinda** for verification (**from 24.09.2021 to 27.09.2021during office hours**) after opening of Technical Bid as mentioned above, along with a set of Xerox copies duly signed by the bidders.
- 1.11 Non-submission of original documents at the time of verification i.e from Date **24.09.2021 to 27.09.2021** during office hours in time will make the tender non-responsive.
- 1.12 The Bid will be received through e-procurement portal from 10.00Hrs on 02.09.2021 to 17.30Hrs on 22.09.2021. Each set of bid document contains technical bid (cover-I) and an intelligible bill of quantity (cover II). The cover-I bid will be opened on 23.09.2021 at 11.30 Hours in presence of the bidders or their authorised representatives, who wish to attend. The bidders who participated in the online bidding can witness opening of the bid from any system logging on to the portal away from opening place. The bids can only be opened by the predesignated officials after the opening time mentioned in the bid. In the event of the specified date of bid opening declared a holiday, the bid will be opened at the appointed time and location in the next working day. Date time and place of opening of Cover-II (Price bid) shall be intimated separately to those bidders who will be found eligible after evaluation of Cover-I (Technical Bid). The intimation letter will be sent through their email address and postal address.
- 1.13 The bidders shall prepare the documents and upload the scanned typed document in PDF format and BOQ in excel format (or as specified in the portal) in appropriate place.
- 1.14 No bidder will be permitted to furnish their tender in their own manuscript.
- 1.15 For submission of bids through e-procurement portal, the bidder shall scan all the written pages of the additional bid security (if applicable) and upload to the system in designated place of the Technical Bid. The online bidder shall have to deposit the "Additional Bid Security" (if applicable) in original in O/o the Chief Engineer, JICA Project, BLB, Sukinda in the date & time mentioned in clause No 1.10 after opening of technical bid. Non-submission of "additional bid security"(if applicable) within the specified period shall debar the bidder from participating in the online bidding system and his portal registration shall be

cancelled. His name shall also be informed to the registering authority for cancellation of his registration.. The Additional Bid security(if applicable) should be valid for a minimum period of 45days beyond the Bid validity period of 120days.

The bidder shall provide the documents in respect of additional bid security (if applicable) in a sealed cover super scribing the name of the work for which the instruments are intended and the officers inviting the Bid. He/She is not required to write his/her name on the cover. The original National Savings Certificate/ Postal Saving Pass Book / Post Office Time Deposit Account / Kissan Vikas Patra / Term Deposit Receipt duly pledged in favour of the Superintending Engineer, Left Canal Division No III, Duburi for Pkg. J (I) and Superintending Engineer, Left Canal Division No IV, Bhuban for Pkg. G (I) & G (II)shall be produced to the Chief Engineer, JICA Project, Brahmani Left Basin, (from date 24.09.2021 to 27.09.2021during office hours) after opening of technical bid. The officer inviting the Bid will not be held responsible for the non-receipt of the same within specified date & time.

The Bid Security declaration of a Joint Venture shall be in the name of the Joint Venture duly signed by the authorised representative of the Joint Venture on behalf of the Joint Venture and shall be legally binding on all members as evidenced by a power of attorney signed by their legally authorised representatives.

- 1.16 The work is to be completed in all respects within **24** (**Twenty-four**) calendar months including monsoon from the date of issue of work order.
- 1.17 The plans, specifications and scope of the work can be seen in the office of the Superintending Engineer, Left Canal Division No III, Duburifor Pkg. J (I) and Superintending Engineer, Left Canal Division No IV, Bhuban for Pkg. G (I) & G (II) during any working day.
- 1.18 The bidders shall carefully study the drawings and specifications applicable to the contract and all documents which will form part of the agreement, detailed specifications for Odisha and other relevant specifications and drawing which are available with the tender document or with the Superintending Engineer, Left Canal Division No III, Duburi for Pkg. J (I) and Superintending Engineer, Left Canal Division No IV, Bhuban for Pkg. G (I) & G (II). Complaint at a future date that plans and specifications have not been seen by the bidders will not be entertained.
- 1.19 The bidder can resubmit his bid through online e-procurement mode, out of which the system shall consider only the last bid submitted to the portal.
- 1.20 Every bidder is expected before quoting his percentage rate, to inspect the site of the proposed work. He should also inspect the quarries and approach road to quarries and locality of the work and satisfy himself about the quality and availability of materials including the medical aids, labour and foodstuff etc. In every case the materials must comply with the relevant specifications.
 - The bidder will be deemed to have satisfied himself that the rates quoted by him in the tender will be adequate to complete the work according to the specifications and conditions attached to it and that he has taken into account all conditions, difficulties that may be encountered during the progress of the work and to have quoted labour rates and materials, entry tax and other duties & taxes, leads, lifts, loading and unloading and freight for materials and all other charges necessary for completion of the work to the entire satisfaction of the Engineer-incharge of the work and his authorised subordinates.
- 1.21 Each tenderer must quote a definite percentage rate over the estimated cost of work and be included in the contract. Tenders containing indefinite terms such as estimated rates or schedule of rates or percentage basis will not be considered,
- 1.22 A pre-bid conference will be held in the O/o the Chief Engineer JICA Project, BLB, Sukinda from 11.30 Hours to 13.30 Hrs on Dt 01.09.2021.
- 1.23 An intelligent BOQ in MS-Excel format shall be made available to the bidder through e-Procurement portal. The bidder shall download that particular Excel sheet and fill in the

percentage rates at the appropriate locations. The bidder is not supposed to change or modify the format of the excel sheet in any form. Bidders are to submit only the original BOQ updates by publisher after entering the relevant fields without any alternation/deletion/modification. In the percentage rate tender the bidder quoting zero value is valid and will be taken as schedule of rates.

- 1.24 The Bidder shall submit the documents in the designated location of Technical Bid(cover-I) and financial bid (cover-II). Submission of bid documents shall be effected by ensuring DSC of appropriate class and thus shall be in encrypted form. The bidder shall only submit single copy of the documents. He is required to check the documents uploaded with the requirements asked for in the bid. Only after satisfying that all the documents have been uploaded, he should activate submit button. His bid shall not be considered responsive and action as per relevant clause shall be taken if he does not provide the required documents or provides illegible documents. Clarity of the documents may be ensured by taking out a sample printing.
- 1.25 The bidder has to quote his percentage rate for the total work inclusive of all taxes, royalties, Cess, Income tax, Surcharge etc(excluding GST)on works contract as applicable from time to time by the Government.
- 1.26 GST will be paid extra as per Govt. Notification on Works bill as applicable from time to time and it will be deducted from works bill and will be deposited in account of the appropriate GST authority.
- 1.27 All taxes, fees, royalties, cess payable under the local rule, income taxes & surcharges as applicable, etc. will be borne by the contractor as admissible. It is implied that the quoted rates are inclusive of such elements and accordingly the taxes will be deducted from the bill as admissible.
- 1.28 **Tax Invoice by the Contractor:** While submitting the works bill, the contractor will have to submit Tax Invoice as per rule 46 of OGST rule 2017.
- 1.29 It is allowed to modify the bid through the e-Procurement portal. The bidder shall have to log in the system and resubmit the documents as asked for by the system including the price bid. In doing so the bids already submitted by the bidder will be removed automatically from the system and latest bid only will be admitted. But the bidder should avoid modification of the bid at the last moment to avoid system failure or malfunction of the internet or traffic jam. if the bidder fails to submit his modified bids within the scheduled time of receipt, the bids already in the system shall be taken for evaluation.
- 1.30 Withdrawal of bid is also allowed in the e-Procurement portal. The bidder has to click on the "withdraw" button and record the necessary justification for the same in the space provided. In addition to this he has to write a letter addressed to officer inviting the bid and upload the scanned document from portal in respective bid. The system shall not allow any withdrawal after the deadline.
- 1.31 The e-procurement portal system shall reject submission of any bid through portal after closure of the receipt time. For all purposes the portal time displayed in the system shall be the time to be followed by the bidder.
- 1.32 The contractor shall have to furnish certificate along with the tender to the effect that he is not related to any officer in the rank of an Assistant Executive Engineer and above / Under Secretary and above in the Department of Water Resources, Government of Odisha.
- 1.33 While determining the validity of tenders the following points shall be taken in to consideration by the authority empowered to accept tenders and his decision in the matter shall be final.
 - a. Any special condition which does not find place in the tender notice and which are not acceptable.
 - b. Indefinite conditions which will make it difficult to assess the financial implication.
 - c. Tenders being incomplete in some important aspects.
 - d. Incomplete schedule of time for completion of the work.

- e. Failure to furnish the specified bid security declaration.
- f. Tendered rates being unduly low and unworkable.
- 1.34 The tender may not be considered unless accompanied by attested true copies of Registration of Firms/ S.S.I. unit / EPM rate contract holder certificate, PAN Card, GST Documents/ Non-Assessment Certificate as the case may be and the original certificates are to be produced on a subsequent date during processing of tender.
 - Attested true copy of work done certificate is to be furnished along with the tender obtaining the same from the Executive Engineer/ Superintending Engineer/authority concerned.
- 1.35 The successful bidder shall within a period of 28 days from the date of receipt of the Letter of Acceptance with due regard to the validity of the tender make an initial security deposit/performance security of 2% of the accepted tendered amount duly pledged in favour of the Superintending Engineer, Left Canal Division No. III, Duburi for Pkg. J (I) and Superintending Engineer, Left Canal Division No IV, Bhuban for Pkg. G (I) & G (II).

Additional Performance Security (APS) shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the Additional performance security as per the following rate as per O.M No- 4559 dated 05.01.2021 of Works Department, Govt. of Odisha.

The applicable Additional performance security (APS) in shape of Term Deposit Receipt pledged / Bank Guarantee in favour of the **Superintending Engineer**, **Left Canal Division No. III**, **Duburi for Pkg. J (I) and Superintending Engineer**, **Left Canal Division No IV**, **Bhuban for Pkg. G (I) & G (II)** from any Nationalized / Scheduled bank in India within a period of 28 days from the date of receipt of the Letter of acceptance failing which the Bid of the successful bidder shall be cancelled. Further preceding for black listing shall be initiated against the bidder. (As per Works Department office Memorandum No.14459/W dated 20.09.2018).

The award of the contract letter shall be generated through the e-procurement system and the bidder shall be intimated in his e-mail address after acceptance of the Bid, followed by Speed Post.

- 1.36 Bidder, whose bid is accepted must submit "programme of work" at the time of execution of agreement in prescribed format for approval of Engineer-in-charge.
- 1.37 The bidder shall sign as a token of final acceptance of the plans, sections with agreements for the work prior to take up the work for execution.
- 1.38 The date of commencement of work shall be notified in work order.
- 1.39 On signing the agreement, the available site will be handed over to the contractor for execution of works.

- 1.40 The work may be split up and distributed among several contractors, if circumstances so demand, for timely completion of the work and the contractor is not entitled to any compensation on this account.
- 1.41 An affidavit shall be furnished by the Bidder at the time of submission of tender paper about the authentication of tender documents including additional bid security (if applicable). The scanned copy of the affidavit is to be uploaded through the e-procurement portal along with the technical bid. The affidavit in original is to be produced before the officer inviting tender after opening of the technical bid.
- 1.42 The lowest amount considering percentage quoted by the Bidder is to be treated as 1st lowest as it is a percentage rate tender subject to fulfilment of other criteria's.
- 1.43 If the rate quoted by the bidder is less than 15% of the tender amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less (decimal up to two numbers will be taken for all purposes) than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, FA & CAO, RIP, the concerned Superintending Engineer and DAO will remain present (Vide Office Memorandum –12366/W dated.08.11.2013 of Works Department, Govt. of Odisha) for finalisation of the bid.
- 1.44 If the successful bidder is decided through the lottery system and the bidder doesn't turn up for agreement after finalisation of tender, then L₂ bidder will be finalised through transparent lottery if number of participants having same quoted rate is more than two.
- 1.45 L1 bidder does not turn up for agreement after finalization of the tender, then he shall be debarred from participation in bidding for three years and action will be taken to black list the contractor. In that case, the L2 bidder, if fulfils, other required criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder otherwise the tender will be cancelled. In case a contractor is black listed, it will be widely published and intimated to all department of Government and also to Govt. of India agencies working in the state.
- 1.46 The bidders are requested to quote percentage excess or less over the estimated cost which is inclusive of all taxes excluding goods and service tax (GST).
- 1.47 Authority reserves the right to reject any or all tenders without assigning any reasons thereof.
