- 1.1 The purpose of this meeting will be to discuss and answer to the queries on any matter that may be raised by the bidders at that stage.

- 3.5 Conditional tender shall not be accepted.
- 3.6 The Chief Engineer, Rengali Right Irrigation Project, Dhenkanal reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- 3.7 The bid document shall form a part of contract and only required documents need to be uploaded during online bid submission for evaluation of bid.
