- 1.** "OWNER" means the Deputy Director, Model Studies & Research, Burla, Dist- Sambalpur 768017.

- 3.** All materials will be sold on "AS IS WHERE IS BASIS". Bids will be deemed to have been made on the clear understanding that intending bidders have satisfied themselves fully in regard to the nature, condition and quality of the materials upon inspection or otherwise.
- 4.** The Deputy Director, Model Studies & Research, Burla, reserves the right to withdraw at any stage from the intended bid sale either before or after the opening the bid by whole or part of the quantity of the materials per number as specified in Schedule 'D'.
- 5.** In the event of any dispute between two or more bidders the materials in question may be put to re-tender. The Deputy Director, Model Studies & Research, Burla, Dist- Sambalpur 768017 may refuse to reject or accept any bid from any person or persons without assigning any reason thereof.
