



2. The cost of Earnest money deposit / Bid security of the amount specified for the work in Col. 06, above the bidder shall Make electronic payment using his / her **Internet Banking enabled** account with designated Bank or their aggregator Bank such as **SBI / ICICI / HDFC** or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from out side the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as bid security.
3. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **16:00 Hours of 09.08.2021 to 17:00 Hours of 16.08.2021**.
4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III**.
5. Bids shall be received only "**On-line**" on or before **17:00 Hours of 16.08.2021**.
6. Bids received "on-line" shall be opened at **11:30 Hours on 17.08.2021** in the office of the **Executive Engineer, Sambalpur (R&B) Division No.I, Sambalpur, Odisha** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The cost of bid documents as mentioned in Column. 7 the bidders shall make electronic payment using his / her internet banking enabled account with designated Ban or their aggregator Bans such as **SBI / ICICI / HDFC** or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks.
8. **Rate quoted by the contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice.**
9. The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish exact amount of differential cost i.e. **estimated cost put to tender minus quoted amount as additional performance security (APS) in the shape of DD / TDR pledged in favour of Executive Engineer (R&B) Division No-I, Sambalpur of concerned Division within 7 days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited** Further, proceeding of blacklisting shall be intimated against the bidder.
10. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers
11. Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit in original to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
12. **Any bidder desirous to avail any facility as per certain Circular/Order of Government has to apply for the same in writing along with bid documents. Claim at the time of opening of tender or later it will not be entertained.**

14. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding".
