1. The Additional Chief Engineer, Angul Irrigation Circle, Angul, Dist: Angul on behalf of Governor of Odisha invites on-line percentage rate basis tender in **double cover system** through e-procurement method for the works mentioned below. The bid should be submitted by the eligible class of contractors as mentioned below registered with the State Governments and contractors of equivalent grade/class registered with Central Government / M.E.S./ Railways through on-line in the Government web-site [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in). (to be eventually drawn in P-1 agreement form). The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of Orissa State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Government within a month of acceptance of bid.

2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) during the bidding period.

3. Government of Odisha has mandated online registration of all categories of contractors in CDMS portal ([www.cdmsodisha.gov.in](http://www.cdmsodisha.gov.in)) vide O.M. No. 12934 dt.23.08.2018 of Works Department. As per the codal provision vide clause No. 12.4 of Appendix IX (A) of O.P.W.D. code Vol.(II) all classes of contractors are requested to register themselves in CDMS Portal. **Tender Inviting Authority will not accept any tender if contractors shall not registered under CDMS portal & their tenders will be rejected.**

4. As per Works Department, Government of Odisha, Office Memorandum letter No. 5984/W dated 27.04.2021, that No Bid Security / Earnest Money Deposit (EMD) has to be deposited and all participating bidder shall submit "Bid Security Declaration" as per Annexure-I of Bid Document. **Non-submission of Bid Security declaration (i.e. in lieu of EMD), the bids will not be considered & rejected.**

5. The Bidder shall transfer **online** the **cost of Bid document** (Non-refundable) amount specified for the works in the table Col-05 above per set towards cost of the bid through process as mentioned in the DTCN vide Office Memorandum No. 17254/W/dated 05.12.2017 of Works Department, Govt. of Odisha.

6. **The bid is to be submitted through the e-procurement portal with documents such as scanned copies of GST Registration Certificate, valid contractor Registration certificate, PAN card, undertaking/certificates duly filled, Affidavit, No Relation Certificate (NRC) and documents required as per the relevant clauses of DTCN with Bill of Quantity (Financial Bid) failing which tenders will be rejected.**

7. As per Works Department Office Memorandum No. 4559 / W, Bhubaneswar dtd.05.04.2021, Additional Performance Security in case of Abnormally Low Bids (ALBs), the Additional Performance Security (APS) is being obtained from the Successful Bidder when the Bid amount is less than estimated cost put to tender to the extent of exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount in shape of Term Deposit Receipt pledged in favour of Divisional Officer / Bank Guarantee in favour of the Divisional Officer from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further, proceeding for Blacklisting shall be initiated against the bidder as per amendment to Para 3.5.5 (v) of OPWD Code, Volume-I vide Works Department Office Memorandum No. 14459/W dated 20.09.2018.

The Additional Performance Security deposit to be made as per fixed the following rate of Additional Performance Security.

**N.B. In the event of the specified date of bid opening being declared a holiday for the officer inviting the Bid, the bids will be opened at the appointed time on the next working day.**

9. The bid for the work shall remain valid for a period of 90 days from the last date of receipt of bid. If any bidder/ tenderer withdraws his bid / tender before the said period or makes any modification in the terms and conditions of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.

10. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor within a period of two years after his retirement from Government service without Government permission.

11. **Engineer contractor** who wants to avail EMD Exemption shall have to furnish scan copy of affidavit to this effect as per works Department Letter No 6315 dt.16.06.2011. **SC/ST contractors** desires of availing benefit as per works Department **Resolution No. 16262 dated 30.10.2018 (Item No.1)** must submit affidavit for the same.

12. **If the rate quoted by the bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids.** But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will **finalize the tender through a transparent lottery system to be drawn on dt.26.10.2021 at 11-00 A.M** in presence of all bidders/ their authorized representatives. In the event of the specified date drawl of lottery being a holiday for the officer inviting officer lottery will be drawn at the appointed time on the next working days.

13. **The labour license is to be produced by the successful Bidder before commencement of work.**
