The Bids received ONLINE shall be opened at **12.00 Noon onwards on dated 16.10.2021** in the office of the Executive Engineer (Civil), Ports and IWT, South Division, Berhampur in presence of bidders who wish to attend. Bidders who participated in the bid, can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
10. The ST/SC contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender document; otherwise they will not be entitled to avail such facilities.


