Separate tenders in plain papers in sealed covers are invited by the undersigned for disposal of Ambassador Diesel Car bearing Registration No. OR-02-AH-7795 and OR-02-AW-2311 of Odisha Administrative Tribunal, Superscribing "Tender for purchasing vehicle bearing Registration No. OR-02-AH-7795 and OR-02-AW-2311" on the cover.

2. The intending tenderers are advised to inspect the Vehicles No. OR-02-AH-7795 and OR-02-AW-2311 in the office premises on any working day during office hour between 11.00 AM to 3.00 PM seven days before submitting tender. The tenderers should deposit earnest money of Rs. 1000/- (Rupees One thousand) only in shape of Bank Draft in favour of the Deputy Registrar, Odisha Administrative Tribunal, Bhubaneswar payable at SBI Government Treasury Branch, Bhubaneswar which will be refunded to the tenderers whose tenders are not accepted except in case of the highest tender. The upset price for the vehicle OR-02-AH-7795 is Rs. 30,000 /- (Rupees Thirty thousand) and for the vehicle OR-02-AW-2311 is Rs. 35,000/- (Rupees Thirty five thousand).

3. The tender/bid should reach the undersigned by 17.08.2017 up to 3.00 PM at the latest and tenders received shall be opened by the Registrar, Odisha Administrative Tribunal, Bhubaneswar at 4.00 pm on 17.08.2017 in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the schedule time.


4. The highest tenderer whose tender will be accepted shall deposit 25% of the offered amount for the vehicle immediately after the sale is confirmed and the balance amount within 7(Seven) days from the date of acceptance of the tender. The successful tenderer shall remove the vehicle from the office premises alongwith the necessary records of the vehicle within seven days from the date of depositing the full amount of the tendered money. Custody or safe guard of the vehicle shall be the responsibility of the tenderer/party and no claim or complaint on that account shall be admissible. In case he/she fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.

5. On failure to remove the vehicle within the aforesaid time, ground rent@ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid site. If the ground rent so charged, exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him/her shall be adjusted towards ^{ground rent} ~~rent~~ and the vehicle shall become absolute property of Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.

6. The vehicle shall not be delivered to the tenderer /party until full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.

7. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
