### AUCTION SALE NOTICE

No. HOME-OE2-SANC3-0014-2016/ 22891, dated 06.07.2020

Sealed Tenders as per the prescribed proforma (enclosed) are invited by the undersigned for disposal of Tata Indigo Petrol Car of Home Department bearing Registration No. OR-05-V-9999, which was purchased on 16.05.2005 and has been declared **condemned** vide this Department Office Order No. 21245 dated 24.06.2020. The upset price of the vehicle is fixed at Rs. 20,000/- (Rupees twenty thousand) only. The above vehicle will be disposed off as and where basis.

2. The intending bidders are advised to inspect the vehicle parked in the Loka Seva Bhavan Premises, Bhubaneswar between 11.00 A.M. to 3.00 P.M. The tender should accompany earnest money deposit of Rs. 1000/- (Rupees One Thousand) only in shape of Bank Draft in favour of D.D.O.-cum-Deputy Secretary to Government, Home Department payable at UCO Bank, Odisha Secretariat Branch, Bhubaneswar, which will be refunded/returned to the bidders whose tenders are not accepted except in case of the successful bidder.

3. The sealed tender/bid superscribed "Auction Sale Bid for Vehicle No. OR-05-V-9999" should reach the undersigned by 21.07.2020 within 3.00 P.M. at the latest and tenders received shall be opened in the Office Chamber of Additional Secretary to Government, Home (OE-II) Department at 4.00 P.M. on the same day in presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.

4. The highest tenderer, whose tender will be accepted, shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within 07 (seven) days of the deposit of the initial amount. In case the tenderer fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.




5. The successful bidder shall take permission and remove the vehicle from the Secretariat premises within 07 (seven) days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent@ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid site. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle & the amount deposited by him shall be adjusted towards ground rent.


