

The DISTRICT PROJECT COORDINATOR, SAMAGRA SHIKSHA, KORAPUT on behalf of Collector-cum-Chairman, RTE-SS, Koraput invites Percentage Rate Bids in Double Cover System for the construction of work as detailed in the table, from the class of eligible contractors as mentioned in column-5(Five) registered with the State Governments and Contractors of equivalent Grades/Class Registered with Central Government/MES/Railways for execution of Building Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the sate PWD in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the following works.

Terms & Conditions

- Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract/tender and other necessary documents can be seen in the website http://tendersodisha.gov.in.
- Bids needn't be accompanied by Earnest Money Deposit/ Bid security of the amount specified for the works. However, the awarded bidder shall deposit the specify amount of EMD/Bid Security before execution of Agreement of the work as per vide letter No. 4559 Dtd. 05.04.2021 of Works Department Govt. of Odisha & Notification No. 8943/F Dtd. 18.03.2021 of Finance Department Govt. of Odisha.
- The Bid documents will be available in the website http://tendersodisha.gov.in from 04.00 PM of 07.09.2021 to 5.00 PM of 28.09.2021.
- 4. The Bidder must process Compatible Digital Signature Certificate (DSC) of Class II or Class III.
- Bids shall be received only "Online" on or before 5.00 PM of 28.09.2021

Bids received "online" shall be opened at 11.30AM on 29.09.2021 in the office of the DISTRICT PROJECT COORDINATOR, RTE, SAMAGRA SHIKSHA, KORAPUT, ODISHA in the presence of Bidders who wish to attend. Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the Bids will be opened on the next working day at the same time and venue.

- The Instruction of Finance Deptt. Govt. of Odisha vide letter No. 4559 Dtd. 05.04.2021 may be referred to.
- 8. As per Govt. of Odisha Finance Department Notification No. 8943/F Dtd. 18.03.2021, it is considering the difficulties faced by the vendors and to facilitate competition in wake of slowdown of the economy due to Covid-19 pandemic, it is hereby decided that no provisions regarding Bid Security should be kept in the Bid Documents and only provision for "Bid Security Declaration" should be kept. Further, wherever, there are compelling circumstances to ask for Bid security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender.
- Detailed information as contained in the D.T.C.N shall have to be strictly adhered to while submitting the tender papers.
- 10. Engineer Contractor desirous to avail the facility of exemption of E.M.D is required to submit an Affidavit in original to the effect that he has not yet available the facility for more than two works during the current financial year. The same of work for which and the authority to which the tender is being submitted must be mentioned in the Affidavit.
- Any Bidders desires to avail any facility as per certain circular/order of Government have to apply for the same mentioning in the Affidavit along with the tender paper. The responsibility of furnishing the copy of the Circular or G.O for allowing special facility in any shall lie on the Bidder claim at the time of opening of tender or later will not be entertained.

- 14. If any of the intending Bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.
- 15 Any Corrigendum/Addendum will be displayed in the website www.odisha.gov.in & http://tendersodisha.gov.in only.
- 16. The Bidders have to submit the Additional Performance Security amount (i.e. estimate cost minus the quoted amount) in shape of valid Term Deposit Receipt/Bank Guarantee covering the period at least for one year or may be extended if required duly pledged in favour of the DISTRICT PROJECT COORDINATOR, RTE, SAMAGRA SHIKSHA, KORAPUT payable at KORAPUT from any Nationalized/Scheduled Bank in original before acceptance of tender, if their quoted amount is less that the estimated cost.
- 17. If after opening of the tender it is seen that, the tender has to be decided through a transparent lottery then the lottery date will be intimated through e-mail, WhatsApp no. and Speed Post. The lottery will be held even if no bidder remains present.
- 18. The authority will not be held responsible for any technical problem/fallure of Network, Server during the schedule dates of online bidding.
- 19. The authority reserves the right to accept or reject any or all tenders, full or part of the tenders without assigning any reason what-so-ever and no intimation will be given to the Bidder. In this account no dispute will be entertained. Any dispute arise subject to Koraput jurisdiction only.
