
Sealed tenders in plain papers are invited from the intended Firms / Contractors / Co-operative Organisations registered under GST Act having Pan Card and up-to-date GST Clearance Certificate with TIN/SRIN for supply of Shoddy Wool for making of Prison Blankets and supply of Raw Materials for preparation of phenyl for the year 2020-2021 as per the quantity given below. The rates should be quoted in Kg/litre inclusive of all taxes and free delivery at the Jail gate of Special Jail, Bhubaneswar at Jharpada, Laxmisagar. The rates should be accompanied with samples to be certified by the purchase committee confirming the required specification. All the tenderers must be present either in person or through their authorised agents/representatives with samples on the day of opening of Tender papers. The selected samples may be put to auction, if necessary. Firms / Contractors / Co-operative Organisations should enclose the copy of certificate showing the dealership of the shoddy wool/raw materials of phenyl. Every tenderer will be required to deposit along with his tender an earnest money @ 2.5% of the estimated value of the articles tendered for in shape of N.S.C. / Postal Savings Pass Book Account duly pledged in favour of the Superintendent of Special Jail, Bhubaneswar. Successful tenderers or bidders will be required to enter into a stamped agreement with the Superintendent, Special Jail, Bhubaneswar within seven days from the date of receipt of intimation by them that their rates have been accepted for the supply of the articles at the Jail Gate in such quantities and at such time as may be required. In addition, they should before entering such agreements, deposit security money @ 10% of the cost of supplies undertaken, in form of Postal Savings Bank Account or in shape of National Savings Certificate duly pledged to the undersigned. Failing compliance within the time specified the earnest money be confiscated. The earnest money deposited by the tenderers whose tenders have not been accepted will be refunded to them after the final acceptance of the tender by the Purchase Committee. The rate fixed by the purchase committee is final. The Chairman, Purchase Committee reserves the right in the public interest to reject any or all tender without assigning any reasons thereof. The sealed tenders quoting rates to be submitted directly to the Superintendent, Special Jail, Bhubaneswar **on or before 5.00 P.M. of 31.12.2020.** Sealed tenders will be opened **at 4.00 P.M. of 05.01.2021** or in consultation with the Chairman of the Purchase Committee.
