The Addl. D.G. of Prisons and Director, Correctional Services, Odisha reserves the right to reject any or all tenders/quotations without assigning any reasons thereof.



GENERAL TERMS AND CONDITIONS

1. The offset price of the above vehicle is Rs.35,000.00 (Rupees thirty-five thousand) only
2. If the last date for the submission of the bid turns out to be a holiday it will automatically be extended to next working day.
3. A bid cannot be withdrawn in any circumstances.
4. The participants should submit the copy of proof of residential address and proof of identity with the bid.
5. The participant/bidder may inspect the above vehicle parked in the premises of Special Jail, Bhubaneswar with due permission from the undersigned during office hours.
6. The participant/bidder should deposit an earnest money (EMD) amounting to Rs.1,000.00 (Rupees one thousand) only for the vehicle in shape of demand draft from any Nationalised Bank/Scheduled Bank drawn in favour of the Superintendent, Special Jail, Bhubaneswar to be payable at Bhubaneswar and the same in original be submitted with the offer/bid at the time of submission.
7. The EMD shall be refunded to the unsuccessful participant/bidder after completion of the auction sale.
8. The undersigned shall not be, in any case, responsible for late submission/receipt of the offer/bid in any manner.
9. The participant/bidder quoted highest offered shall deposit 25% of the offer amount then and there as the initial deposit and he/she shall deposit the rest of the offer amount within seven days of the deposit of the initial amount. In case he/she fail to deposit the total offer amount within the stipulated time, the deposit, including the earnest money deposit (EMD) shall be forfeited. The EMD of the successful bidder will be adjusted at the time of final payment of the offer amount in time. GST as per rule shall be levied on the offered price payable by the participant/bidder.
10. The successful bidder shall take permission of the Superintendent of Special Jail, Bhubaneswar and shift the vehicle from the Jail premises within seven days of the deposit of the final amount. On failure of the shifting the vehicle from the jail campus within the stipulated time, ground rent @ 1% of the offered amount shall be charged on the participant/bidder for each day or a part thereof till shift of the vehicle from jail campus. If the ground rent so charged exceeds the sale price deposited by the concerned participant/bidder, then the concerned participant/bidder shall cease to have any right on the vehicle and the amount deposited by the concerned participant/bidder shall be adjusted towards ground rent. Tools and implements of the spare parts shall not be delivered with the vehicle.
11. In case of failure to deposit the full amount within the stipulated time by the successful participant/bidder, negotiation among the other unsuccessful participant/bidder will be made, if so required, to take the vehicle on deposit of the highest auction price offered by the first participant/bidder.
12. The entire dispute shall be subjected to jurisdiction of the Civil Court situated at Bhubaneswar.
