2. The envelop carrying the bid must be super scribed in capital letter with " **OFFER FOR AUCTION SALE OF VEHICLES**".

3. The intending tinkerers are advised to inspect the above vehicles parked at the Odisha Human Rights Commission, Bhubaneswar in between 11.00am to 4.00 pm, on any working day. Each tender must accompany with an earnest money deposit of Rs.1,000/- (Rupees One Thousand) for each vehicles, in shape of Bank Draft made in any Nationalized Bank in favour of Secretary, Odisha Human Rights Commission, Bhubaneswar, which shall be refunded to the Tenderers, whose tenders are not accepted except in case of successful bidder. The price offered shall not be less than the minimum (offset) price as mentioned above in each case. The bidder should mention in the tender regarding the Vehicle No/Model/Make for which he would participate.

4. The Tender should reach the undersigned by Registered Post/Speed Post on or before 27.10.2021 by 12.00 noon at the latest and tenders received shall be opened by the Auction Sale Committee in the Office Chamber of Secretary, Odisha Human Rights Commission, Bhubaneswar on 27.10.2021 at 3.00 pm in the presence of the Tenderers of their authorized representatives. If this day is declared later as a Government Holiday, then the Tenders will be received and opened on the next working day as per the scheduled time. The undersigned will not be held responsible regarding late submission/receive of the Tender in any manner.

5. The highest Tenderer, whose tender is accepted, shall deposit immediately 25% of the offered amount then and there, as initial deposit. He shall deposit the balance amount within 7(seven) days of the deposit of the initial amount. In case, he fails to make deposit to the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.

GST as admissible shall be paid on the bidding cost by the successful bidder.

6. It will be the responsibility of the successful bidder to look after the vehicle at the its own cost and the Odisha Human Rights Commission will not be responsible for any damage done by way of pilferage or otherwise and no claim on this account will be entertain.
7. The successful bidder shall take permission and remove the vehicle from the O/o- OHRC, Bhubaneswar within 7 (seven) days of deposit of the bid amount. On failure to remove the vehicle within the aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, the Tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards the ground rent. Tools and implements of spare parts shall not be delivered with the vehicle.
8. The Authority reserves the right to reject any or all tenders without assigning any reason thereof.
