The Superintending Engineer, Drainage Division, Bhadrak on behalf of Governor of Odisha invites on-line percentage rate tender through e-procurement in single cover system for execution of work under C.D.R.-2021-22. The bids should be submitted by 'D'/ 'C' class of contractors registered / empanelled with state Government of Odisha & contractors of equivalent grade / class registered with other State Governments / central Government / Government undertakings / MES / Railways / other statutory authorities for execution of works to be eventually drawn in P-1 form through on-line in the Government website https://www.tendersodisha.gov.in. The bidders should have necessary portal enrollment (with own digital signature certificate). The registered bidders outside of Odisha state can also participate in this on-line tender process after necessary portal enrollment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month of acceptance of bid.

- 2. The bidders have to participate in online bidding only. The website for online bidding is https://www.tendersodisha.gov.in.
- 3. The bid documents will be available in the above mentioned website from **10.00 Hours of 30.10.2021 to 08.11.2021 up to 17.00 Hours** for online bidding.
- 4. Date of opening of Bid **11.30 Hours on 09.11.2021** office of the Superintending Engineer, Drainage Division, Bhadrak.
- 5. The bidder shall transfer online the cost of bid paper (non-refundable) of the amount specified for the work in the table Col. 7 as part of this bid through a process as mentioned under DTCN.
- 6. Mode of Bid / Period of availability of bid on-line / date and time of bidding on-line / Last date of seeking clarification / date of opening of bid papers.

- 7. **Bid validity**: The bid for the work shall remain open for acceptance for a period of **90 days** from the last date of receipt of bids. If any bidder withdraws his bid before the said period or makes any modification in the terms and condition of the bid, the EMD deposit at the time of submission of tender shall stand forfeited.
- 8. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without permission of Government.
- 9. The original documents along with a set of it's Xerox copies against the scanned copy of RC, (valid contractor registration certificate), GSTIN registration Certificate, PAN Card, Affidavit and requisite documents submitted through web site should be produced in the office of Superintending Engineer, Drainage Division, Bhadrak for verification on demand after opening the Technical Bid.
- 10. Any addendum / corrigendum /cancellation of above tender will be published in the web-site www.tendersodisha.gov.in and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
- 11. Only those bidders who successfully remit their Cost of Tender Paper on submission of bids would be eligible to participate in the tender/ bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure.
- 12. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the works are available in web-site www.tendersodisha.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested tenderers may obtain further information at the web-site www.tendersodisha.gov.in.
- 13. Other details including details of Portal Registration, Submission of bid, Resubmission and withdrawal of bid can be seen in the bidding document which is available in web-site www.tendersodisha.gov.in.
- 14. The bidder except those who are exempted from paying Bid security/EMD as per Para21 of FDOM No 4939/F Dated 13.02.2012 has to submit "Bid security Declaration" in
 lieu of Bid security/EMD with stipulation that if he withdraw or modify his bid during
 period of validity etc., he will be suspended for 3 (Three) years as per office
 Memorandum No.8943/F dt.18.03.2021 of Finance Dept. Govt. of Odisha.
- 15. The bidders are required to submit the attested copies of the valid Registration certificate, PAN Card and GSTIN registration Certificate along with the Bid documents otherwise his/her Bid shall be declared as non-responsive and thus liable for rejection. The Original documents are to be produced before the undersigned as and when required. Engineering contractor who is desirous to avail the facility of exemption of EMD is required to submit the affidavit on-line to the effect that he/she has not yet availed the facility for more than two works during the current financial year. Name of the two works and authority to which the tender is being submitted must be mentioned in affidavit failing which; the tender will be liable for rejection.
- 16. If rate quoted by the bidder is less by 15% or more of the amount put to tender, then such a bid shall be rejected and tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the amount put to tender, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/their authorized representatives, the concerned Superintending Engineer and DAO will remain present. Tender shall be finalized as per the recent amendment to codal provision vide OM No-10224 Dt 01.09.2015 of Works Department, Govt. of Odisha if required.
- 17. As per Office Memorandum No.4559/W dt.05.04.2021 of Works Department, Govt. of Odisha, Additional Performance Security (APS) is being obtained from the Successful Bidder when the Bid amount is less than estimated cost put to tender to the extent of exact amount as given below in shape of Term Deposit Receipt pledged in favour of Divisional Officer (i.e. Superintending Engineer, Drainage Division, Bhadrak) / Bank Guarantee in favour of the Divisional Officer (i.e. Superintending Engineer, Drainage Division, Bhadrak) from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further, proceeding for Blacklisting shall be initiated against the bidder as

per amendment to Para 3.5.5 (v) of OPWD Code, Volume-I vide works Department office Memorandum No.14459/W dated 20.09 2018

- 18. If the rate quoted by more than one bidder is found to be equal and lowest & within the permissible limit, then the tender will be finalized by a transparent lottery system on 17.11.2021 at 11.30 Hours in the office chamber of the Superintending Engineer, Drainage Division, Bhadrak in presence of the qualified bidders or their authorized representatives who so ever desire to be present. If the schedule date either for opening of tender or lottery for finalization of tender is declared as Govt. holiday then the same will be conducted in the next working day.
- 19. If the 1st lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years & action will be taken to black list the contractor.
- 20. The bidders shall furnish an affidavit on-line at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, valid GSTIN registration certificate and security etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all; Labour license is to be produced by the successful bidder at the time of agreement.
- 21. For a particular work a bidder can submit only one bid. Submission of more than one bid by a bidder for a particular work will be liable for rejection of all such bids of the concerned bidder.
- 22. All correspondence to the bidders will be made by e-mail address given by them in the bid confirmation report of e-procurement system Government of Odisha along with the bid. The authority will not be responsible for invalid e-mail address.
- 23. The single tender received in the first call shall be cancelled without opening the bid. The acceptance of the single tender received even after retendering should have prior approval of next higher authority.
- 24. As Goods and Service Tax has come into force with effect from 01.07.2017, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act 2017.
- 25. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
