1. The Superintending Engineer, Angul Irrigation Division, Angul on behalf of Governor of Odisha invites on-line **percentage rate basis tender in single cover system** through e-procurement for the works detailed in the table below from the eligible class of contractors registered with State Governments & contractors of equivalent grade/ class registered with Central Government / MES / Railways for execution of Civil works. The proof of registration from the appropriate authority shall be enclosed along with the bid. The registered bidders outside of Odisha State can participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the Odisha State Govt. within a month of acceptance of bid.

- Government of Odisha has mandated online registration of all categories of contractors in CDMS portal (www.cdmsodisha.gov.in) vide O.M. No. 12934 dt.23.08.2018 of Works Department. As per the codal provision vide clause No. 12.4 of Appendix IX (A) of O.P.W.D. code Vol.(II) all classes of contractors are requested to register themselves in CDMS Portal. **Tender Inviting Authority will not accept any tender if contractors shall not registered under CDMS portal & their tenders will be rejected.**
- As per Works Department, Government of Odisha, Office Memorandum letter No. 5984/W dated 27.04.2021, that No Bid Security / Earnest Money Deposit (EMD) has to be deposited and all participating bidder shall submit "Bid Security Declaration" as per Annexure-I of Bid Document. **Non-submission of Bid Security declaration (i.e. in lieu of EMD), the bids will not be considered & rejected.**
- The Bidder shall transfer **online** the **cost of Bid document** (Non-refundable) amount specified for the works in the table Col-05 above per set towards cost of the bid through process as mentioned in the DTCN vide Office **Memorandum No. 17254/W/dated 05.12.2017** of Works Department, Govt. of Odisha.
- The bid is to be submitted through the e-procurement portal with documents such as scanned copies of GST Registration Certificate, valid Registration certificate, PAN card, Affidavit, No Relation Certificate (N.R.C.) and documents required as per the relevant clauses of DTCN with Bill of Quantity (Financial Bid). Non submission of required documents, the bid will be treated as non-responsive.**
- As per Works Department Office Memorandum No. 4559/W, Bhubaneswar dtd.05.04.2021, Additional Performance Security in case of Abnormally Low Bids (ALBs),** the Additional Performance Security (APS) is being obtained from the Successful Bidder when the Bid amount is less than estimated cost put to tender as per following table in shape of Term Deposit Receipt pledged in favour of Divisional Officer / Bank Guarantee in favour of the Division Officer from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further, proceeding for Blacklisting shall be initiated against the bidder as per amendment to Para 3.5.5 (v) of OPWD Code, Volume-I vide Works Department Office Memorandum No. 14459/W dated 20.09.2018.

N.B. In the event of the specified date of bid opening being declared as a holiday the officer inviting the Bid, the bids will be opened at the appointed time on the next working day.

9. The bid for the work shall remain valid for a period of 90 days from the last date of receipt of bid. If any bidder/ tenderer withdraws his bid / tender before the said period or makes any modification in the terms and conditions of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
10. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor within a period of two years after his retirement from Government service without Government permission.
11. **Engineer contractor** who wants to avail EMD Exemption shall have to furnish scan copy of affidavit to this effect as per works Department Letter No 6315 dt.16.06.2011 . **SC/ST contractors** desires of availing benefit as per Works Department **Resolution No. 16262 dated 30.10.2018 (Item No.1)** must submit affidavit for the same.
12. **If the rate quoted by the bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids.** But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will **finalize the tender through a transparent lottery system to be drawn on 17.11.2021 at 11.00AM in presence of all bidders/ their authorized representatives.**
In the event of the specified date for drawal of lottery being declared a holiday for the officer inviting Bid, lottery will be drawn at the appointed time on the next working day.
13. The successful bidder shall submit original affidavit, EMD along with other documents in original for verification during drawl of agreement.
14. As Goods and Service Tax has come into force with effect from 01.07.2017, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act 2017. The rate of individual items of work are exclusive of GST and bidders are to quote there rates exclusive of GST.
15. The Addendum/ Corrigendum / Cancellation if any will be hoisted in the website only.
16. All correspondences & informations if any required will be sent to the bidders in their provided e-Mail address.
17. The authority reserves the right to cancel any or all the bids without assigning any reasons thereof.
