EXPRESSION OF INTEREST FOR THE FOOD COURT 16th TOSHALI NATIONAL CRAFTS MELA 2021

The 16th Toshali National Crafts Mela will be organized at Janata Maidan, Bhubaneswar from 15th to 27th December 2021 (The dates may be rescheduled as per the COVID 19 guideline issued by Govt). There will be a food Court with stalls for Odia, Indian & Continental dishes etc.

The event will be organized as per the guidelines of COVID 19 specified by Govt of Odisha/ Govt of India. All the food stall staff should be well trained regarding the guidelines of COVID 19 as they have to obey the guidelines themselves and ensure following of the guidelines by the customers very strictly. The food stall staff will use mask and gloves during their duty and use sanitizer from time to time and maintain social distance from each other. They will have to maintain cleanliness and healthy atmosphere in the food court area and take all required steps for regular sanitization of the allotted food court area. Every food stall have to keep sanitizer for their own use and for customer's use also.

“Expression of Interest” is invited from interested hoteliers/ restaurants/ SHGs/ Individuals for opening of Food Counter in the Food Court of the mela ground during the said period. The request letter addressing to “The Head, Food & Sanitation Committee, 16th Toshali National Crafts Mela 2021” may be submitted along with menu chart, quantity in weight/ piece and price list on or before 5 P.M on 22.11.2021 at the Directorate of Textiles & Handlooms, Satya Nagar, Bhubaneswar, Odisha (in both hard and soft copies) and online through Email Id: sericultureorissa@yahoo.co.in / toshalifair@gmail.com. “State Specific Ethnic Food” will be given preference for participation. The selected participants will be required to deposit a nominal charge of Rs. 10,000/- (Rupees Ten Thousand) only in shape of DD drawn in favour of “Member Secretary, State Institute for Development of Arts & Crafts”, Bhubaneswar, which is non refundable. The selected participant is required to furnish an undertaking by way of affidavit to follow the COVID 19 guidelines prescribed by Govt., not to use any kind of banned plastic materials (as notified by the Govt.) in the food counter, use only eco friendly products, strictly follow all types of fire safety norms as per Govt. rules & regulations, not to do any extra decoration/signage/counters outside the allotted area, shall be solely responsible for all liabilities for running of the counter, to abide with any other conditions as to be imposed by the authority and submit the food license issued by City Health Officer of B.M.C for opening of food counter in 16th TNCM-2021. The authority reserves the right for finalization of the list of participants in the food court of Toshali National Crafts Mela 2021 and to reject/cancel any or all the EOIs/allotments without assigning any reasons thereof.
