
The interested bidders/vendors/firms are required to submit a copy of the authorisation certificate from the concerned OEM.

The approved Firm should supply & install the laptops within seven days from the date of issue of purchase order. There should be minimum 1 year warranty for the item so supplied which should be clearly mentioned in the quotation. The Quotationers should submit E.M.D of Rs. 25,000/- in shape of Demand Draft drawn in favour of Deputy Secretary to Government, Sports & YS Department along with the quotation.
