The Superintending Engineer, Southern Minor Irrigation Circle, Berhampur on behalf of the Hon'ble Governor of Odisha invites **online percentage rate tender** through "e" procurement for the works as detailed in the Summary of bid notice.

1. Bidding is open to all eligible bidders as defined under Odisha Contractors Registration Act of Works Department from time to time. Bidders registered in **relevant classes** as per eligibility criteria of class to each works in Summary of Bid Notice **column-6** under the Government of Odisha/ Other State Government/ Government of India/ State or Central Government Undertakings are also eligible to bid. The registered bidders outside the state can also participate in this online tender process after necessary portal enrolment, but shall have to subsequently undergo registration with appropriate authority within one month from acceptance of tender.

2. Bidding documents can only be available on-line in the Government of Odisha website ([www.odisha.gov.in](http://www.odisha.gov.in) & [tendersodisha.gov.in](http://tendersodisha.gov.in)) from 16.12.2021 to 30.12.2021 up to 5.00 PM for preview, download & submission.

3. The Bidders must possess compatible **Digital Signature Certificate of Class-II or Class-III**. The web site for the on-line bidding is [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).

4. Bids must be accompanied by a **non-refundable fee** as indicated at **Column-4** of Summary of Bid Notice towards **cost of bid documents** to be deposited online. Instructions to be followed for online payment available in the e-Procurement portal during the processing of tender by the bidder and **Bid security declaration** to be furnished in prescribed format as per works department Office Memorandum No. 5984 dtd. 27.04.2021. Tenderers desire to hire machineries or equipment from outside the state are required to furnish 2% of the amount put to tender as bid security.

5. Tender shall be uploaded separately for Technical Bids (Cover-I) & Financial bid (Cover-II) etc in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The on-line bidders should upload the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including EMD accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuineness of the documents should be uploaded. The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuineness of signature put on other uploaded documents including affidavit and lease deeds is beyond purview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.

6. The Technical bid (Cover-I) generally consists of GSTIN,PAN, Registration Certificate, Affidavits, Bid security declaration and any other information required by Officer inviting Tender (OIT) as per Rule- 16.1 in Appendix-IX (A) of OPWD Code. Volume-II.

7. Fails to furnish original Technical Documents before the designated Officer within the stipulated date and time action will be taken as per Rule- 23.1 & 23.3.1 in Appendix-IX (A) of OPWD Code. Volume-II.

8. The bidder shall execute a "Bid Security Declaration" in lieu of bid security with stipulation that if they withdraw or modify their bid during period of validity etc, they will be suspended for the time specified in the tender document. Bidders are required to download the "Bid Security Declaration Format" from the DTCN and upload the same with dated signature, as per works department Office Memorandum No. 5984 dtd. 27.04.2021.

9. The **cover-1 (Technical Bid)** will be opened in the office chamber of the Superintending Engineer, Southern Minor Irrigation Circle, Berhampur in his office online at **12.30 PM on dated 31.12.2021** in presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. Opening of **Cover-II (Financial Bid)** shall be intimated through web site and E-mail specified for the purpose in e-tendering process to those bidders who will be found eligible after evaluation of Technical Bid (Cover-I).

10. **Engineering Contractor** wishing to avail exemption of EMD shall furnish an affidavit to the effect that, he has not availed the benefit during the current calendar year vide office memorandum No. 12914 dated 23.08.2018 of works Department and original licence shall be submitted before the authority for making necessary entry in the original licence, if successful & selected for awarding the work as per Letter No FA-Codes-6/2011-600 dated 18.1.2011 of Works Department. Non response to deposit Additional Performance Security deposit will invite forfeiture of E.M.D, blocking of D.S.C. and licence issuing authority will be moved for cancellation of contracting licence.

11. The Engineering Contractor desire to avail the facility of **exemption of E.M.D** is required to submit an affidavit mentioning the name of work for which and the authority to which the tender is being submitted, failing which he will not entitle to get any facility. Similarly, SC/ST contractors seeking exemption of E.M.D or price preference required to produce an affidavit to this effect. Both Engineering and SC/ST contractors should submit the affidavit in writing regarding the facility to concerned officer inviting tender, otherwise they will not entitle to get the facility. The SC/ST contractors having Degree/ Diploma in Engineering are not allowed to avail both the benefits. The Bidders shall have to remit the EMD/ Bid Security amount @ 1% (One percent) of the value of work put to bid online as part of the Performance Security Deposit. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to remit online additional one percent (1%) EMD/ Bid Security. Bids uploaded online without Bid Cost and Bid Security in the prescribed mode shall be rejected.

12. **Additional Performance Security** shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rate than the estimated cost put to tender shall have

to furnish the exact amount of the APS in the rates as noted below in shape of NSC/ POTD/ Term Deposit receipt of any scheduled Bank duly pledged to Executive Engineer, M.I. Division Ganjam No.II, Berhampur / K.M.I Division, Phulbani, within seven days of issue of letter of acceptance (LOA) otherwise the bid shall be forfeited. Further, Proceeding for black listing shall be initiated against bidder as per works department. OM No 4559 dated 05.04.2021.

**13.** The amount quoted by bidders shall remain **valid for 90 (ninety) days** from the date of opening of financial bid (Cover-II). If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.

14. If the rate quoted by the SC and ST category contractors come to 14.99 %(**decimals up to two numbers will be taken for all practical purposes**) less than the estimated cost after availing 10% price preference as per Para-2 of Works Department Resolution No. 27748, Dt. 11.10.1977, then the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other category of contractors whose rates are 14.99 % less than the estimated cost in presence of all bidders/their authorized representatives, the Executive Engineer and Divisional Accounts Officer.

**15.** Quality control tests as per specification for all items of the work executed will be taken in Government Quality Control Laboratory of Southern Minor Irrigation Circle, Berhampur. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect.

**16.** No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without due permission of the Government.

**17.** The bidder shall have to furnish "**No relation**" certificate in shape of affidavit along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.

**18.** **Clear scanned copies** of tender, PAN, valid and active GSTIN certificate, **no relation certificate** in shape of affidavit, **original valid contractor registration certificate with online registration in CDMS portal, Bid Security Declaration form, affidavit regarding genuineness and authenticity of document**, and affidavit to avail price preference in case of SC & ST contractors should be uploaded along with the Bid document.

19. The original affidavit regarding correctness of all documents for each work separately should be made and scanned copy of such affidavit is to be uploaded online, failing which his tender will not be considered and rejected during opening of tender.
20. Consequent upon implementation GST with effect from 01.07.2017, the rate offered by the agency should be excluding all taxes and duties and including labour cess and royalty, G.S.T as applicable shall be paid extra and TDS as applicable shall be deducted from the bill.
21. The Scanned copies of **original valid contractor registration certificate with online registration in CDMS portal, valid and active GSTIN registration certificate, PAN, bid security declaration form, affidavit** including all required paper uploaded through website of the valid successful lowest bidder should be produced in original to the S.E S.M.I. Circle, Berhampur within 5 days of opening of tender. In the eventuality of failure of the lowest successful bidder to produce the original document, will be debarred in future from participating in tendering for 3 years and will be black listed by the competent authority.
22. The single tender received shall be cancelled without opening the bid in 1st call.
23. Government of Odisha Works Department. Office memorandum No. 12366 dated. 08.11.2013 should be followed scrupulously except amendment to Para-3.5.5 (v) of OPWD code, Vol.-I.
24. Government of Odisha Works Department. Resolution No. 16262 dated. 30.10.2018 on grant of concession (s) to Schedule Caste & Schedule Tribe contractors should be followed.
25. The contractors would be responsible for procurement of materials from authorized sources and voluntarily disclose the source of procurement for the purpose of billing. Besides, the bidder would be required to submit the details of quarry for procurement while submitting the bids.
26. Other details can be seen from the bid document.
27. The Authority will not be held responsible for any technical snag or network failure during online bidding.
28. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
