- 3. The Authority will not be held responsible for any technical snag or network failure during online bidding.
- 4. The Cost of Bid Documents and initial bid security to be deposited on electronically transfer system as per provision of e-tender.
- 5. The Bidder may ask questions in the e-procurement portal using his/her DSC from Dt.27.12.2021at 10.00 AM to Dt.05.01.2022 up to 5.30 PM.
- 6. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid Security (Col-4) instead of 1%. - 15. The amount quoted by bidders shall remain valid for 90 (ninety) days from the date of opening of financial bid.
