NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **Superintending Engineer, P.H. Division, Bhubaneswar, Odisha** on behalf of Governor of Odisha invites **Percentage Rate Bids** through e-Procurement in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Single cover system from **"B", "C & "D" Class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience and expertise in execution of **Similar Type of Works** and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN on **"Percentage Rate Basis"** to be eventually drawn up in the standard **P1 Contract Form**. The bid should be submitted on-line in the website www.tendersorissa.gov.in by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.
