7. <u>Minimum Eligibility Criteria :-</u>

- i) Registered Contractors should have successfully Completed & Commissioned Works of similar type valuing not less than 30% of the estimated cost in any one financial year during the last 5 (five) years (Details in DTCN). The firm shall have to submit the performance certificate of completed & commissioned works constructed by them for satisfactory performance from appropriate authority i.e. not below the rank of Executive Engineer / equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- ii) The Manufacturer/authorised dealer/MSME/authorised system house/Joint Venture Organisation / Registered Contractors should have annual financial turnover of not less than **40% of the** estimated cost **(Details in DTCN)** in any one financial year in the civil construction works during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per completed financial year (on compound basis) shall be given on the annual turnover of the preceding years. Bidder shall furnish complete audited annual financial year statements for last five years including audit report, balance

- sheets, profit and loss accounts statement all other schedules etc in support of meeting the financial criteria as mentioned above.
- 8. The bid for the work shall remain open for acceptance for a period of 120 (One Hundred Twenty) days from the date of opening of price bids. If any Bidder / Tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 9. Bidder has to furnished the bid security declaration in letter head in schedule format as DTCN.
