The Superintending Engineer, E.M.I. Circle, Keonjhar on behalf of Governor of Odisha invites percentage rate bids through e-procurement to be received in online mode only for the works as detailed in the table below.

14. Bidding is open to all eligible bidders as defined under Odisha Contractors Registration Act of Works Department from time to time. Bidders registered as **mentioned against works** as per eligibility criteria of class to each work in Annexure to Bid Notice column **7** under the Government of Odisha/ Other State Government/ Government of India/ State or Central Government Undertakings is also eligible to bid. The registered bidders outside the state can also participate in this online tender process after necessary portal enrollment, but shall have to subsequently undergo registration with appropriate authority within one month from acceptance of tender. Interested bidders may obtain clarifications regarding the said work from the office of the **Superintending Engineer, Eastern Minor Irrigation Circle, Keonjhar / Executive Engineer M.I. Division, Keonjhar** prior to participation in the bid.
15. Any legal disputes arises is subject to jurisdiction of concerned Divisional Authority.
16. Bidding documents can only be available on-line in the Government of Odisha website <http://www.odisha.gov.in> & (<http://tendersodisha.gov.in>) from **03.01.2022 to 21.01.2022** up to 05.00PM for preview, download & submission.
17. The Bidders desiring to participate in “On-line” bidding must possess compatible **Digital Signature Certificate of Class-II or Class-III**. The web site for the on-line bidding is <http://tendersodisha.gov.in>.

18. **The cost of tender paper and EMD as tabulated in the annexure shall be received online along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The procedure of bid submission using electronic payment of tender paper cost and EMD by the bidder may be referred in Works Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN.**
19. Tender shall be uploaded separately for Technical Bids(Cover-I) & Financial bid (Cover-II) etc in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The on-line bidders should upload the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including bid security accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuinity of the documents should be uploaded. **The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuinely of signature put on other uploaded documents including affidavit and lease deeds is beyond preview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.**
20. One bidder can submit only one tender paper for each of the works for which tender invited in this notice in his own DSC. Submission of more than one tender paper for any particular of work by a bidder through different DSC or through his own DSC for a particular tender will be liable for rejection of all such tenders.
21. **Engineering Contractors wishing to avail exemption of EMD shall furnish an affidavit to the effect that he has not availed the benefit for more than two times during this financial year and original license shall be submitted before the authority for making necessary entry in the original license, if successful & selected for awarding the work as per Letter No FA-Codes-6/2011- 600 dated 18.1.2011 of Works Department. Non response of successful bidder to deposit additional performance security deposit in shape of Demand Draft/Term Deposit Receipt pledged in favour of Executive Engineer, M.I. Division, Keonjhar within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited and blocking of D.S.C. and license issuing authority will be moved for cancellation of contracting license.**
22. **“Additional Performance Security** shall be obtained from the bidder when the bid amount is less than the estimate cost put to Tender. In such an event only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional performance Security (APS) in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Divisional Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder” as per Government of Odisha, Works Department Office Memorandum, File No.-07556900012013-14299/,dated, 03/10/2017 of Amendment to para-3.5.5(v) of OPWD Code Vol-I

23. **In view of “Additional Performance Security”, the Government is pleased to fix the following rate of APS**

24. The amount quoted by bidders shall remain **valid for 90 (ninety) days** from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & conditions of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his/her registration as contractor including forfeiture of bid security deposited.
25. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without due permission of the Government.
26. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
27. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for three years and action will be taken to blacklist the contractor. In that case the L 2 bidder if fulfils all other criteria would be called for drawing agreement for execution of work subject to the condition that L 2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
28. If rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/ their authorized representatives, the concerned Executive Engineer and DAO will remain present.
29. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and in case failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
30. Office Memorandum File No. 07556900042013 (PtII)-7885/W dated 23.7.2013 will be treated as part of DTCN and instruction to bidder. (enclosed to DTCN)
31. Other details can be seen from the bidding document.
32. **Submission of fake TDRs shall lead to rejection of Bids and criminal action shall be initiated against the concerned bidders.**
33. **GST to be imposed as per Govt. guidelines from time to time.**
34. **The Engineering Contractor who will avail EMD exemption should produce the original contractor license before conduct of transparent lottery.**
35. **The bidders should submit the original documents of Registration Certificate with CDMS Registration, GST,PAN ,Affidavit etc. for verification from dt.25.01.2022 to 04.02.2022 within the official working hour in the office of the Superintending Engineer eastern Minor irrigation Circle, Keonjhar else the bid is liable for rejection.**

36. In case of lottery need to be conducted in accordance with the works department order no.12366 dtd 8.11.2013, the lottery date will be intimated subsequently in the tender web site.
37. The agency concerned should strictly adhere into the instruction of COVID-19 pandemic situation in the mind and observations of SOP and any such other instruction issued by Govt. time to time. Similarly failure to payment part in to above such contact due to any such unavoidable situation may kept in mind for timing due to such situation.
38. The bidder or agent authorized by him/her should remain present at the time of opening the Technical bid.
39. Vide memorandum No.8943/F dated 18.03.2021 of Finance Department Clause No.03, **no provision regarding Bid Security should kept in the Bid Document and only provision for “Bid Security Declaration” should be kept. This instruction will be applicable for all the tender issued till 31.12.2021. Beyond 31.12.2021 any alternation/addition can be seen in tender portal (<http://tendersodisha.gov.in>)**
40. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
