- 14. In case of Engineer Contractor not having availed EMD exemption in more than two works an undertaking to the affect that "Being an Engineer Contractor, I have not availed EMD exemption in more than two works in this financial year of 2021-22" has to be clearly mentioned in the

Affidavit. The Engineer Contractor has to upload all the pages of licence including blank pages for verification of entries made in award if works with exemption of EMD.

Office Memorandum No. 5984 dt. 27.04.2021.
