Interested parties having all demolishing machineries and equipments as per list enclosed against the concerned work may submit their quotations in sealed cover by personal delivery in the box placed for the purpose in the office of the undersigned / Regd. Post/ Speed Post by 3.00PM on or before **Dt.24.01.2022** stating therein that they are willing to abide by the specified terms & conditions of the department failing which the quotation(s) shall be rejected. **Earnest money** mentioned in the list against the work in shape of NSC / KVP / POSB Account / Deposit receipt of Nationalised Bank duly pledged in favour of the Superintending Engineer, Cuttack (R&B) Division No.I, Cuttack, copy of GST & PAN should accompany the quotation, failing which the quotation will be rejected outright. The bidders have to furnish documents towards ownership / lease deed of the above machineries to be deployed in demolition work.

The Earnest money thus deposited shall be refunded to the unsuccessful quotationers after finalization of quotation process and the same shall be refunded to the successful quotationer only after receipt of a certificate from concerned SDO regarding complete removal of all materials & debris from the above said site.

Before quoting the cost, interested persons / parties may inspect the buildings/ structures and assess the profit / loss taking all incidental charges and cost of materials into account and quote the amount accordingly. Any complaint whatsoever as to mis-calculation / mis-judgment regarding profit / loss after quoting the amount shall not be entertained. The Quotations will be opened by the undersigned or Officer authorized by him on **Dt.24/01/2022** at 4PM in presence of person / parties who wish to attend. The highest quotationer whose quotation will be accepted by the competent authority will have to deposit the accepted amount in full together within 7(seven) days time and will thereafter on receiving clearance from the undersigned, demolish the structure upto ground level and remove the dismantled materials including debris within one month and clear-up the worksite failing which the materials left back shall be considered as property of Govt. and the entire EMD deposited shall be forfeited to the Govt.
