Bidders registered as SC, ST& P.H contractors desiring to avail concession(S) /price preference as per prevailing rules should also clearly mention regarding claim for avail such benefits in writing in shape of an affidavit and enclose necessary document and affidavit in support of their claim along with their bid, failing which their case will not be considered for availing price preference as per the above rule. No claim in this regard after opening of bid will be entertained.
- 9. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of rest of bids.
