- **The amount put to tender is exclusive of 12% GST. The intending bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST applicable on works contract shall be paid over the bill amount at the time of payment of bill.**
- **The Bid must be accompanied with Bid Security Declaration (SCHEDULE-J) as per Finance Deptt. Govt. of Odisha Circular No. 8943 dt. 18.03.2021 & subsequent Works Deptt. Office Memorandum No. 5984 dt. 27.04.2021. No provisions regarding Bid Security should be kept in the Bid Documents and only provision for "Bid Security Declaration" should be kept for all participating venders.**

2. Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State failing which the bid security shall be forfeited the said bid stands cancelled.
3. The Bid documents shall be available in the website: <https://tendersorissa.gov.in> from **09.03.2022 at 09.00A.M. The bid document can be downloaded from website, for submission of the bid in the prescribed format, by the intending bidder. The bid cost shall be non-refundable.**
4. Bids shall be received only "on line" on or before **25.03.2022 up to 05.00 P.M.** The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class- III and should follow the changes/ modifications/ addendum to DTCN if any.
5. Bidders should remit the Cost of Tender Paper through NEFT/RTGS payment using internet banking of the bank in which the bidder holds his account, by adding the account number as mentioned in the challan as an interbank beneficiary. Bid Security (Earnest Money Deposit) presently not applicable as per Office Memorandum No. 8943 dated 18.03.2021 of Finance Department, Govt. of Odisha but **BID SECURITY DECLARATION** shall be given by the Contractor.
6. Bids received on line on due date and on time shall be opened at **11.00** Hours on **28.03.2022** in the office of *Executive Engineer, RWS&S Division, Malkangiri* in the presence of the bidders or their authorised representations who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The bidders have to submit the hard copies of the documents that have been uploaded in the e-tender portal for verification in the office of the Executive Engineer, RWS&S Division, Malkangiri whenever intimated, failing which their bid shall be rejected.

9. While evaluating tenders provision made in the SBD/ OPWD code will be strictly followed. Also the Govt. Circulars issued from time to time will also be followed strictly.
