QUOTATION CALL NOTICE NO. 138 OF 2021-22.

The Superintending Engineer, P.H. Division, Sambalpur on behalf of Governor of Odisha, invites sealed quotations from the Water Tanker Owners / Contractors duly registered under State/ Central Govt. for deployment of Mini Truck mounted/ Truck mounted / Tractor mounted water tanker of capacity 4 KL for distribution of water to public during **Summer-2022** (April, May & June) in the under mentioned ULBs.

1. The quotation must be accompanied by Bid Security Declaration / 1 % security deposit of the quoted value in shape of NSC, POTD, Post Office Saving Bank Account, Deposit receipt of any scheduled bank, and duly pledged in favour of **Executive Engineer, P.H. Division, Sambalpur**.
2. The quotation will be received in the office of the **Superintending Engineer, P.H. Division, Sambalpur / Additional Chief Engineer, P.H. Circle, Sambalpur/ Assistant Executive Engineer** of respective P.H. Sub-Division directly in the Tender Box within the stipulated date & time i.e. **5.00 PM of dt. 07.04.2022**.
3. The quotation can be received through speed post/ Regd. post latest upto **5.00 PM on dt. 07.04.2022**.
4. Quotation shall be opened by the Superintending Engineer, P.H. Division, Sambalpur in presence of the quotationers or their authorized representative on the next day i.e. **11.30 AM dt. 08.04.2022**.
5. If the above days are declared later as a govt. holiday then the quotations will be received or opened on the next working day as per the schedule time.
6. Quotation received after due date and time shall not be entertained and the authority shall not be held responsible for delay or missing of the quotation during postal transit.
7. Quotation received without Bid Security Declaration / EMD shall be rejected.
8. Quotationer should enclose attested copy of valid GST, Pan card & registration certificate etc. along with quotation.
9. In case the intending bidder does not own Mini Truck mounted/ Truck mounted / Tractor pulled water tanker , he is required to furnish the original necessary agreement in proper form duly executed with the owner of the vehicle/ water tanker towards hiring of the same for the above purpose.
10. The rate should be quoted per day per vehicle basis against each ULB and inclusive of hire charges of Vehicle, Fuel & Lubricants and other consumables alongwith salary of driver & helper etc.

11. The quotationer are not required to write their name on the outer cover containing the quotation documents. They are only required to write the name of the work and the authority who had invited the tender. Quotation should be quoted for each work in separate pockets.
12. The number of vehicle and number of days to be engaged may vary as per requirement.
13. Attested Xerox copy of valid Registration certificate /fitness certificate /insurance copy /pollution testing certificate / Driving license of driver of the proposed vehicle shall be furnished along with the quotation.
14. The authority reserves the right to reject any or all the quotations without assigning any reason thereof.
15. The no of vehicle to be engaged & no of days can be changed as per actual requirement depending upon situation.
