## **Section 1: Purpose of EOI**

Teacher Education in Odisha is offered by Government Degree Colleges and Government Teacher Education Institutions with an intake capacity of 3350 per annum. Each year, around 2 lakh students aspire to get admission to various Teacher Education Courses e.g. B.Ed., B.H.Ed., Integrated B.Ed./M.Ed. Selection of candidates is done through a Computer Based Entrance Test.

Higher Education Department, Government of Odisha invites Expression of Interest (EOI) from prospective Service Providers for conduct of end-to-end Computer Based Entrance Test (CBT) annually for next five years subject to the condition that on non-satisfactory performance, the agreement with the Selected Service Provider can be terminated at any point of time within the five years. The CBT shall be held in the identified Test Centres having adequate ICT facility. The selected Service Provider is required to provide services with respect to:

- All works relating to conduct of CBT (ICT and furniture inclusive of electrification, power back up, support of manpower and network cabling with identification of Examination Centre etc.).
- Assessment of answer sheets and publication of result in a fair and transparent manner.
- Keeping audit trails of the entire CBT examination pertaining to each applicant.

## Section 2: Eligibility criteria

The Service Provider interested to participate is required to possess the following eligibility criteria and must submit documentary proof of the same without which the "Response to EOI" will be rejected.

  deliberately suppressing the information may result the "Response to EOI' being
  summarily rejected.
- 3. "Response to EOI" received late will not be entertained.
- 4. All pages of the 'Response to EOI' shall be numbered, attested by the authorized person of the Service Provider and submitted as a package along with forwarding letter on Service Provider's letter head.
- 5. The Higher Education Department, Odisha may seek additional documents or clarifications as and when required from the Service Providers.
- 6. In case of a large number of eligible Service Providers responding to the EOI, Government reserves the right to shortlist 15 to 20 Service Providers, based on the annual turnover for three financial years i.e. 2018-19, 2019-20, 2020-21, i.e. Service Providers with higher average annual turnover shall be shortlisted. All the eligible Service Providers or all the shortlisted Service Providers, as the case may be, are required to give presentation on their credentials, capabilities and suggested scope of work on a date, time and venue to be intimated subsequently. Failure to make presentation will make the Service Provider concerned ineligible for Request For Proposal (RFP).
- 7. Subsequent to the presentation made by the Service Providers, detailed scope of work shall be finalised in shape of RFP document and price bid shall be invited only from those Service Providers who made their presentations.
- 8. Higher Education Department, Odisha reserves the right to annul this EOI process at any time without incurring any liability to the affected Service Provider.
