## INVITATION FOR BIDS (IFB) NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement NOTICE INVITING TENDER

JICA assisted Orissa Integrated Sanitation Improvement Project in Cuttack implemented by OWSSB invites Percentage Rate Bids through e-Procurement in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Two Bid system (Technical Bid and Price Bid) from the bidders of eligible class of contractors registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/Railways having experience in any civil works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the Standard P-1 Contract Form on percentage rate basis.

1. **Bid Submission Criteria:** Bidders may submit bids for one or more than one of the twelve Packages separately. However, one bidder shall be awarded maximum two packages only. But, in case of 'B' class contractors, the total estimated value of 2 packages to be awarded should not exceed Rs. 3.00 crores. For A or above class contractors, the total estimated value of 2 packages to be awarded may or may not exceed Rs. 3.00 crores. Financial bids shall be opened sequentially in decreasing order of the value of estimated cost of packages i.e. the bids shall be opened in order of Package- 6, 2, 4, 3, 12, 1, 11, 7, 8, 10, 9 & 5.

- Tender Document: The tender document consists of two parts. DTCN Part-I: General & Technical Bid is common for all Packages. The bidder will fill the Package No., for which he intends to submit the bid, at requisite places. DTCN Part-II: Price Bid / Bill of Quantity (BOQ) is specific for each package.
- 3. Mode of Submission of tender: The bid should be submitted on-line in the website www.tendersodisha.gov.in by eligible bidders. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration as

- per prevailing rules with the appropriate authority of the State Government before signing agreement.
- The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
- The original documents i.e., Affidavits, Undertakings & Certificates as per the Schedules and Annexure of DTCN that have been uploaded by the bidder in the etender website should be submitted for verification during evaluation.

- 7. Eligibility Criteria:-The eligible Class of Contractor should be Class B and above(as per the Proceedings of the meeting on revision of the existing provisions under the Rules of Appendix-VIII of the OPWD Code, Volume-II (PWD Contractors Registration Rules-1967) under the Chairmanship of E.I.C (Civil), Odisha held on dt. 26.09.2019). The firm shall have to submit the performance certificate of the works constructed by them for satisfactory performance from appropriate authority i.e., not below the rank of Executive Engineer /equivalent.
- 8. The bid for the work shall remain valid for a period of 120 (One Hundred Twenty) days from the date of opening of Price Bid. If any Bidder/Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 9. Bids from Consortium/ Unincorporated Joint Venture is not acceptable.
