- 3. Bids must be accompanied by a non-refundable fee as indicated at Column-6 of Annexure towards cost of Tender Paper for the works. The cost of Tender Paper is to be remitted online as per instruction issued in Works Department office Memorandum No. 17254 dated 05.12.2017. Scanned clear copies should be uploaded. The Bidder desire of hire machineries or equipment from outside the state or owned but deployed outside the state are required to furnished 2% of the amount put to tender as bid Security. Only those bidders who successfully remit their cost of Tender Paper on submission of bids would be eligible to participate the tender/ bid process. The bidders with pending of failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC the designated Banks shall not be held responsible for such pendency or failure.
- 4. Regarding Bid Security (EMD) : As per Finance Department Govt. of Odisha No 8943 Dated- 18.03.2021, due to Covid-19 pandemic, no provision regarding Bid Security should be kept in the Bid Documents and only provision for "Bid Security Declaration" should be kept. The bidders should execute a Bid Security Declaration in lieu of Bid security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents. Only successful bidder is to provide the Bid security / EMD before signing the Agreement.

Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their SSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8. A bidder shall not be permitted to bid for works in the M.I. Organization responsible for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer & Junior Engineer (both inclusive).
- 9. The online bidders should upload the scan clear copy of the affidavit in support of correctness or proof of the information submitted including Bid Security Declaration accompanied with tender by them.
- 10. Engineer Contractor desires to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which he will be not entitle to get any facility. Similarly ST/SC contractors seeking exemption of 50% E.M.D or price preference required to produce an affidavit to this effect. The ST / SC contractors having Degree/ Diploma in engineering are not allowed to avail both the benefits. Both Engineering and ST / SC contractors should submit the affidavit in writing regarding the facility to concerned Officer inviting tender, otherwise they will not entitle to get the facility.

- 11. The bidder should not quote in any tender 15% less than the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids.
- 12. Additional performance security (APS) is being obtained from the Successful Bidder when the Bid amount is less than the estimated cost put to tender to the extent of exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount in shape of N.S.C/Postal Saving Bank Pass Book / K.V.P / Post Office Term deposit receipt / Deposit receipt of any Nationalized /Schedule Bank duly pledged in favour of the Executive Engineer, M.I. Division, Nayagarh within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. - 16. The bidders subject to be disqualified, if they have record of poor performance, such as abandoning the work, not properly completing the previous contract with the organization in ordinate delays in completion other projects, litigation history or financial failures.
- 17. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of the registration as contractor including forfeiture of bid security deposited.
- 18. Quality control tests as per specification for all items of the work executed will be taken in nearly Govt. Quality Control Laboratories of Minor / Medium / Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect.
- 19. Scanned clear copies should be uploaded. Non-visible copies on Documents may be liable for rejection.
- 20. The works are very urgent in nature and non drawing of the agreement within 07 days from finalization of tender; it will be automatically cancelled with forfeiture of EMD as per Codal provision.
- The eligible bidders whose quoted rate is 14.99% less than the estimated cost put to tender and the eligible price preference bidders comes to 14.99% less will attend the transparent Lottery system on dated 29.04.2022 at 11.00 AM.
- 22. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.

- 25. At the instant when the 1st lowest bidder failed to deposit APS money in time, the bid of the successful bidder will be cancelled and a fresh lottery may be conducted excluding the 1st lowest bidder.
