The **Superintending Engineer, P.H. Division, Keonjhar** on behalf of Governor of Odisha invites **Percentage Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **single Bid system** from '**D**' & '**C**' class **Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience in laying of pipes and fittings, fulfilling minimum eligibility criteria as stated in DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bid should be submitted on-line in the website [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Govt. of Odisha can also participate e-procurement after necessary Portal Enrolment, but shall have to subsequently registered themselves with the appropriate registration before award of the work / signing of the Agreement as per relevant registration norms of the state.

6. The scanned copy of Registration Certificate, GST, PAN, Affidavits including required papers shall be up loaded through website and should be produced in original to the **Superintending Engineer, P.H. Division, Keonjhar** for verification at the time of bid opening.
