The **Superintending Engineer, Sambalpur (R&B) Division-I, Sambalpur** on behalf of Governor of Odisha invites **Percentage Rate** bids in **Double & Single Cover System** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with ELBO, Bhubaneswar, Odisha for execution of Civil works . The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

The cost of Earnest money deposit / Bid security of the amount specified for the work in Col. 06, above the bidder shall Make electronic payment using his / her **Internet Banking enabled** account with designated Bank or their aggregator Bank such as **SBI / ICICI / HDFC** or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from out side the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as bid security.
3. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **16:00 Hours of 09.05.2022 to 14:00 Hours of 17.05.2022.**
4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
5. Bids shall be received only "**On-line**" on or before **14:00 Hours of 17.05.2022.**
6. Bids received "on-line" shall be opened **at 14:30 Hours on 17.05.2022** in the office of the **Superintending Engineer, Sambalpur (R&B) Division No. I, Sambalpur**, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The cost of bid documents as mentioned in Column. 7 the bidders shall make electronic payment using his / her internet banking enabled account with designated Ban or their aggregator Bans such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks.
8. **Rate quoted by the contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice.**
9. The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish exact **amount of differential cost i.e. estimated cost put to tender minus quoted amount as additional performance security (APS) in the shape of DD / TDR pledged in favor of Superintending Engineer (R&B) Division No-I, Sambalpur of concerned Division within 7 days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited** Further, proceeding of blacklisting shall be intimated against the bidder.
10. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers
11. Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit in original to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
12. **Any bidder desirous to avail any facility as per certain Circular/Order of Government has to apply for the same in writing along with bid documents. Claim at the time of opening of tender or later it will not be entertained.**
13. Other details can be seen in the bid documents.
14. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding".
15. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely **withdraw** from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
16. Any corrigendum / Addendum will be displayed in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) only.
17. If the office happens to be closed on the opening day due to subsequent declaration as holiday in Govt. or local authority the tenders will be opened on the immediate next working day at same time and venue respectively.
18. The online bidder shall have to produce the original documents for verification in support of scanned copies and statements uploaded in the portal within three days from the date of opening of the bid.
19. Conditional tender will be summarily rejected. The Department reserves the right to reject any or all bids without assigning any reason thereof.
