NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **Superintending Engineer, P.H. Division, Keonjhar** on behalf of Governor of Odisha invites **Percentage Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **double Bid system** from **'B' & 'A' class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience and expertise in Design, Construction, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bid should be submitted on-line in the website www.tendersorissa.gov.in by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Govt. of Odisha can also participate e-procurement after necessary Portal Enrolment, but shall have to subsequently registered themselves with the appropriate registration before award of the work / signing of the Agreement as per relevant registration norms of the state.

- Mode of Submission of tender: Tender should be submitted online in www.tendersorissa.gov.in
- The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
- The original documents i.e. Affidavits, Undertakings certificates as per the schedules and Annexure of DTCN that have been uploaded by the bidder in the e-tender website should be submitted for verification during evaluation.
- The bidder should make payment through online receipt towards Tender Paper Cost. No off line receipt of Tender Paper Cost will be allowed in e-Procurement portal of Government of Odisha.

The scanned copy of Registration Certificate, GST, PAN, Affidavits including required papers up loaded through website should be produced in original to the **Superintending Engineer, P.H. Division, Keonjhar** for verification by **17:00 Hrs of dt.18.04.2022** so as to enable opening of Technical Bid i.e., at **11 Hour of dt.19.04.2022**.

9. To arrive at the value of completed works, Value of multiple contracts executed in a financial year shall be considered. For this purpose, the Completion certificates given by the authorities for any one financial year shall be considered. In case value of works executed in any one financial year is not available in the Certificates, the same shall be calculated on a pro-rata basis, considering that the total completed value and the time schedule in days.

10. The Bidder should have not been black listed by any Govt./ Govt. Undertaking on the bid opening date. **Self-declaration certificate** by Bidder in the form of Affidavit is to be submitted.

11. The bid for the work shall remain valid for a period of **120 (One Hundred Twenty) days from the date of opening of Price Bid**. If any Bidder/ Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.

12. Bids from Consortium/ Unincorporated Joint Venture is not acceptable.
