TERMS OF REFERENCE

The Project Director, OCTDMS on-behalf of the Governor of Odisha has decided to produce documentary films of **10-15** minutes duration each in digital format through independent film makers on the following topics:

- 1. Development of Pani Panchayat Institution under OIIPCRA
- 2. Implementation of Command Area Development (CAD) under OIIPCRA

All interested independent filmmakers may submit their proposal, duly completed in all respects with the following documents (enclosed Annexures I to IV) in a sealed cover super-scribed as "**Proposal for production of documentary Films under OIIPCRA-2022**" addressed to the Project Director, OCTDMS, Department of Water Resources, Government of Odisha, 7th Floor, Rajiv Bhawan, Bhubaneswar-751001 so as to reach on or before **15th May, 2022** upto **3:00 pm** for consideration and the Technical Proposals will be opened on the same day at **3.30 pm** for technical evaluation:

- Bio-data along with address for communication which includes Pin Code No., City, Phone No, Mobile Number and email address.
- 2) The synopsis and concept of proposed film in one page should briefly define the content in the form of topic that the film will deal with. It should also indicate broadly the techniques to be used like voice over, music, interviews, candid shots, graphics etc. The synopsis should also give a preliminary indication of the form that the film may take such as classical, impressionistic, portrait, documentation, compilation, experimental and so on. The introduction of the project is given in **Annexure-I** to guide in preparation of synopsis.
- Brief description of Technical Team viz., Scriptwriter, Cameraman, Sound Recordist, Editor & Music Director, with name and brief bio-data.
- 4) It is advised that the proposals may be submitted to the Procurement Section of OCTDMS at 7th Floor, Rajiv Bhawan, Bhubaneswar by hand or by Speed Post/ Registered post/ Courier addressed to the Project Director, OCTDMS, 7th Floor, Rajiv Bhawan, Bhubaneswar-751001 well before the closing date and time. The proposals received after the closing date and time will not be considered under any circumstances.
- 5) Procedure for selection and others terms and conditions are at Annexure-II & III.
- Details of budget in prescribed format at Annexure-IV should be submitted in a separate sealed cover along with the proposal.
- The film is to be completed in all respects and submitted to Project Director, OCTDMS within 45 days of signing of contract.

Annexure-I – Project Introduction

1. INTRODUCTION

The Government of Odisha in partnership with the Government of India is implementing the World Bank assisted project "Odisha Integrated Irrigation Project for Climate Resilient Agriculture (OIIPCRA)". The project aims to intensify and diversify agricultural production, enhance climate resilience and improve water productivity in selected cascades of Odisha. The project is funded by World Bank and to be completed over a period of 6 years from 2019-2025. The total project cost is US \$ 235.40 million (Rs. 1,683.00 Cr approx.). 538 Nos. Of Minor Irrigation tanks identified in 15 Districts of Odisha in 4 river basins e.g., Rushikulya, Budhabalang, Baitarani and Tel Sub-basin covering about 56,200 Ha irrigated tank commands and about 70,000 Ha of rain-fed area surrounding these tank commands in Bolangir, Balasore, Bargarh, Bhadrak, Boudh, Gajapati, Ganjam, Jajpur, Kalahandi, Keonjhar, Mayurbhanj, Nabarangpur, Nuapada, and Subarnapur district for rehabilitation under OIIPCRA.

The project is implemented jointly by three line-departments, i.e., (1) Department of Water Resources, Government of Odisha, (2) Department of Agriculture and Farmers Empowerment, Government of Odisha, and (3) Department of Fishery and Animal Resource Development, Government of Odisha, with clearly defined role and responsibilities. The overall project implementation is being managed through "Odisha Community Tank Development and Management Society (OCTDMS)" a Special Purpose Vehicle (SPV) created under the Department of Water Resources, Government of Orissa to conceptualize and operationalize the World Bank assisted Orissa Community Tank Management Project (OCTMP) during the year 2006. The society is registered under the Societies Registration Act-1860 at Bhubaneswar. The project envisages execution through primary and secondary institutions from the State Project Unit to the Community Level Groups with facilitation of Support Organization.

2. ASSIGNMENT OBJECTIVE

Objective of the Assignment is to prepare a short educational film/ Class room video to introduce the project and works relating to the respective topics under OIIPCRA.

- 2.1 The film/documentary will be a combination of animated 3D digital movie capturing the step-by-step narration with back ground audio-visual lectures, interviews if any on i). Procedure of works under the topic, ii). Role & responsibilities of various stake holders and iii). Portraying of a successful institution/implementation of works under OIIPCRA or any Minor Irrigation Project relating the topic of the films as invited.
- 2.2 The theme and other inputs (information) will be provided by the project authorities. The film maker has to make all such research, scripting of the sequences, prepare the technical design if any that may require and capture 3D animated graphics and onsite video of the preliminary selection, interviews with the farmers/ Water Users/ Stakeholders and related procedures etc. to prepare the film.

Annexure – II Qualification Criteria for the Film Makers/Individuals

- The film makers should have experience in producing short films/ documentaries of repute in social interest/ Water/ Climate/ Environment or Agriculture related at least 2 (two) numbers in last 5 years.
- 2. Film Makers/ Individuals having Awarded/ recognised in State/ National/ International levels for their short films/ documentaries shall be preferred with more weightage in a decreasing order from International to National and State Level awardees.
- **3.** The Film Makers shall have the unit/ proficiency for adding animations/ 3D modelling animations/ picturisation in the films required for educational series.
- 4. The Film Makers/ individuals having produced/ directed the films will be preferred.
- 5. The Film Makers/ individual should not be blacklisted with the Govt. of Odisha at the time of opening of the proposal or signing of contract for the consultancy.

6. Deliverables & other Conditions:

- a) Proposal received without the complete set of required documents referred above and after due date will not be considered.
- b) The department shall not be responsible for delay, loss or non-receipt of application through post/Courier.
- c) Necessary Income-Tax will be deducted at source as stipulated under the provisions of Section 194-C of the Income Tax Act, from the payments to be made to the awardee.
- d) Any disputes arising out of the tender notice, process and finalization of this bid shall be subject to jurisdiction of the High Court of Odisha, Cuttack.
- e) The film maker will have to indemnify the Project Director, OCTDMS against any damages resulting from violation of any copyright or intellectual property right or any law in force for breach of condition that may form part of festival/ screenings.
- f) The Rushes to be given in DPX file on Hard Drive.
- g) Rough-cut is to be given on DVD disc to the project authorities.
- h) Final Film in HD format in DPX file on Hard drive.
- i) Sound on DVD (International Track, R.R. Track & Music Pieces)
- j) Sound tracks including ambience sound, location sound etc as **.wav** files on Hard Drive.

Annexure – III General Conditions

- i. Medium: Film is to be shot in Hi-Definition digital video format with 50 mbps recording bit rate and at least 4:2:0 colour depth (4:2:2 colour depth preferred) with world class production and technical values.
- **ii.** Language: The film is to be produced with commentary if any in Odia language with subtitles in English. The interviews/ dialogues/ talkie in any regional language should be subtitled in English.
- iii. Agreement: An agreement in prescribed format shall be executed between the Project Director, OCTDMS and the applicant whose proposal is accepted. The agreement shall contain inter-alia, details of duration, format, language, cost, schedule for release of funds, schedule for various stages of film making and final material to be submitted to the Project Director, OCTDMS on completion of film. The amount assigned for the film will be inclusive of all taxes which the film makers may have to pay, such as service Tax, VAT, GST etc. to the Government.
 - Copyright, marketing and all other rights of film produced under the agreement shall vest with the Project Director, OCTDMS.
 - The film is to be completed within 45 days from the date of signing of the agreement. The production of the film will be strictly governed by the terms and conditions contained in the Agreement that the producer has to enter into with the Project Director, OCTDMS.
- iv. Procedure for selection: The proposal shall be scrutinized by a Preliminary Screening Committee of OCTDMS on the basis of submitted concept and synopsis. If a proposal is found interesting/ appealing, the film maker will/may be asked to come for a pitching session with the Final Selection Committee.
 - a. The Final Selection Committee will make recommendations based on criteria such as idea, treatment, and the profile of the film maker and his team. The Selection Committee may indicate/ recommend the duration, budget and time for completion of the project as a part of its recommendations.
 - b. The financial bids of the proposals recommended by the Final Selection Committee will be opened and the film will be assigned to the lowest quoted bidder.
 - c. On the recommendation of the Selection Committee, the Project Director, OCTDMS will assign the film to the applicant.
 - d. The agency on satisfactory performance may sign for other new assignments on mutual agreements.
 - e. The Project Director, OCTDMS shall exercise the powers to reject any or all of the proposals without assigning any reasons thereto or accept/ assign the film to any person whose proposal has been received or any person otherwise, without assigning any reason whatsoever and his decision in this regard is final and binding.
