The Superintending Engineer LSRRC & B Division, Balangir on behalf of Governor of Odisha invites **Percentage Rate Tender** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **Double Cover System** (Cover-I: General & Technical Bid and Cover-II: Financial Bid) from **"B" Class or "A" Class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways having experience and expertise in Design, Construction, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bid should be submitted on-line in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State.

5. The original documents i.e., Affidavits, Undertakings & Certificates as per the Forms and Annexure of DTCN that have been uploaded by the bidder in the e-tender website should be submitted for verification during evaluation. The Technical Bid will be opened on **Dt.13.06.2022 at 11.00 AM.**
6. All Bidders/Contractors are bound to register themselves in CDMS Portal developed by State Procurement Cell, Odisha, Bhubaneswar.
7. Bid validity period of the Tender is for a period of **90 days** from the last date of submission of Bid.
  - a) The bid must be accompanied with the "**Bid Security Declaration**" instead of EMD / Bid Security in the standard format i.e. Form-II of bid document.
  - b) The bids without "**Bid Security Declaration**" will be summarily rejected.
  - c) In case of successful Bidder, if the Bidder withdraws the Bid during the validity period of Bid / if he fails to submit ISD as specified in instructions to bidder/ if he fails to sign the Contract for whatever the reason, they will be suspended for a period of three years.
  - d) Contractors exempted from payment of EMD also shall have to submit "**Bid Security Declaration**" as per **Form-II** of Bid Document.
8. The bidder should upload all the documents as per clauses of DTCN in the pdf format. Non submission of No Relation Certificate and Affidavit as per Form- I & III of bid document, is liable for rejection of the Tender.
9. The Original Affidavit should be retained by the bidder with him. The bidders have to furnish the original documents to the Superintending Engineer, LSRRRC & B Division, Balangir as & when required for verification of tender. The successful bidder have to submit the original Affidavit to the Superintending Engineer LSRRRC & B Division, Balangir before drawal of the Agreement.
10. Additional Performance Security (APS) shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount (as per the following table) of differential cost i.e., estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of **Term Deposit Receipt** pledged in favour of Superintending Engineer, LSRRRC&B Division, Balangir Payable at **Balangir** in favour of **Superintending Engineer, LSRRRC&B Division Balangir** from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at **Balangir within Seven (7) days of issue of Letter of Acceptance (LoA) (by e-mail)** to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceeding for Blacklisting shall be initiated against the Bidder.

11. Signing of Bid: The on-line bidder shall digitally sign on all statements, documents, certificates up loaded by him, owning responsibility for their correctness / authenticity as per IT ACT 2000. If any of the information furnished by the bidder is found to be false / fabricated / bogus, his/her EMD / Bid security shall stand forfeited and his/her registration in the portal shall be blocked and the bidder is liable to be blacklisted. Authority reserves the right to reject any or all the tenders without assigning any reason thereof. No tenderer can demand the cause of rejection of his/her offer.
  12. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
  13. The contractor will write **percentage excess or less up to two decimal point** only if he writes the percentage excess or less up to more than two decimal point, the two decimal point shall only be considered without rounding up.
  14. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers as per works Department letter No. 4985/WE dated 28.03.2007.
  15. The bidders shall go through these eligibility criteria before online bidding such as valid Contractors Registration Certificate, PAN & GSTIN Certificate, No relation Certificate, Affidavit etc. and all these entries should be very clear and legible manner free from any ambiguity. Any deviation shall liable to rejection of bid.
  16. If the rate quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more, than one bids is quoted at 14.99% (Decimals up to two numbers will be taken, for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representative, the concerned Superintending Engineer and DAO will remain present.
  17. In case of **The Schedule Caste / Schedule Tribe** bidders who wants to avail the price preference he must have to furnish the required affidavit to avail price preference.
  18. The online bid will be opened on **13.06.2022 at 11.00 A.M.** in the office of the undersigned in the presence of the bidder or their authorized agents, who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be received and opened on the corresponding next working day at the same time and venue. If so may bidders have quoted the same rate will be finalized by a transparent lottery system. . The date of lottery will be intimated to all the eligible bidders in due course.
  19. The Single Tender received in the first call shall be cancelled without opening of the bid. The acceptance of a single tender received even after re-tendering should have prior approval of the next higher authority.
