

3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
4. The bidder should make payment through online towards Tender Paper Cost. No off line receipt of Tender Paper Cost will be allowed in e-Procurement portal of Government of Odisha.
5. The scanned copy of GST, PAN, Affidavits including required papers shall be uploaded through website and should be produced in original to the **Superintending Engineer, P.H. Division, Keonjhar** for verification as and when required so as to enable opening of the Bid at **11:00 Hrs of dt.24.05.2022**.

Minimum Eligibility Criteria:

7. The bidder should not be black listed/debarred/disqualified with respect to the quality issues by any Govt./Govt. undertaking as a procuring entity, in the last three years from the date of submission of the tender (Self-declaration certificate shall be submitted by the bidder).
8. The products should have valid BIS marking/ ISI mark. Copy of the valid BIS License of the product to be supplied if any.
9. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty Days)** from the date of opening of price bids. If any Bidder/Tenderer withdraws his bids/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
10. Bid security declaration shall be submitted in lieu of EMD in Schedule-A, non-submission of Bid Security Declaration will call for rejection of bid.
