- 8. The bidder shall have authorization by the manufacturer for participating in the bid.
- The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) Days** from the date of opening of price bids. If any Bidder/Tenderer withdraws his bids/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
