*Corrigendum Notice No. 2 to Tender Call Notice No.85 of 2021 -22*

Following modification have been made in Tender Call Notice No.85 of 2021-22 due to some unavoidable reasons:

1. The eligible class of contractor for the work serial no. 03, which was earlier "A & Special Class" is now modified as "A & B Class".

2. The **Clause 4.6, 28.3 & 36.2 of the DTCN** for the work serial no. 1 to 3 which was earlier "Only those Bidders who meet the eligibility criteria as specified in Clause 3.1, test of responsiveness specified in Clause 4.1, evaluation criteria as per clause 4.4(A) and if their available bid capacity is more than the total bid value shall be shortlisted for financial opening", "Applicants who meet the minimum qualification criteria will be qualified only if their available bid capacity at the expected time of bidding is more than the total estimated cost of the works" & "In no case, the contract shall be awarded to any bidder whose available bid capacity is less than the evaluated bid price, even if the said bid is the lowest evaluated bid. The contract will in such cases be awarded to the next lowest bidder at his evaluated bid price" respectively are now modified as "**Out of Number of projects in particular Notice Inviting Bid, a bidder can only participate for projects of value equals to or less than 3 times of its Bid Capacity. In case of participation in projects more than the above limits, the Authority reserves the right to cancel any bid which exceeds the prescribed limit as mentioned above before opening of the Financial Bid without any further clarification to the bidder.**"
