The **Superintending Engineer**, **P.H. Division**, **Keonjhar** on behalf of Governor of Odisha invites **Percentage Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **double Bid system** from **'B' & 'A' class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience and expertise in Design, Construction, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD.** The bid should be submitted on-line in the website **www.tendersorissa.gov.in** by eligible class of contractors.
